IN THE MATTER OF THE PETITION OF PUBLIC SERVICE ELECTRIC AND GAS COMPANY FOR APPROVAL OF THE ENERGY STRONG PROGRAM

Due to questions about the impact of my October 11, 2013 Order granting Rate Counsel's motion to compel the release of certain information on the previously adopted schedule for this proceeding, on Thursday October 17, 2013, I authorized the suspension of the procedural schedule established in the August 2, 2013 Pre-hearing Order.

On October 23, 2013, a telephone discovery and scheduling conference was held in this matter. During the conference the parties were requested to attempt to resolve the issues arising out of setting an amended procedural schedule. As the parties have been unable to agree on a new procedural schedule, after review of submissions from PSE&G and Rate Counsel as well as comments by other parties, I hereby issue a revised Procedural Schedule attached to this Order as Exhibit A, to be adhered to by all parties.

Parties are reminded that answers to all discovery should be as complete as possible, and include supporting material to avoid the need for multiple rounds of requests. Similarly, all testimony should be filed with supporting workpapers or other materials.
