



On May 29, 2018, the New Jersey Division of Rate Counsel submitted a letter to the Board stating that it Counsel does not object to the Company's tariff filing.

**DISCUSSION AND FINDINGS**

The Board has carefully reviewed the record in this matter including the Letter Petition and Rate Counsel's comments. Moreover, as represented by the Company, the modifications are intended to comply with N.J.A.C. 14:4-2.6 and do not propose changes to rates. Accordingly, the Board **FINDS** the proposed modifications are reasonable, in the public interest and consistent with N.J.A.C. 14:4-2.6.


The Board **HEREBY APPROVES** the proposed modifications to PSE&G's electric and gas tariffs as requested by the Company in its Letter Petition. The Board **FURTHER ORDERS** PSE&G to file tariffs consistent with the Board's Order by July 7, 2018.

The Company's costs will remain subject to audit by the Board. This Decision and Order shall not preclude nor prohibit the Board from taking any actions determined to be appropriate as a result of any such audit.


The effective date of this Order is July 2, 2018.




