RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION CONCERNING THE PETITION OF MARINA DISTRICT DEVELOPMENT COMPANY, LLC REQUESTING THE ISSUANCE OF A TEMPORARY CASINO KEY EMPLOYEE LICENSE TO ANTHONY CARATOZZOLO PURSUANT TO N.J.S.A. 5:12-89b(4) AND -89e AND TEMPORARY QUALIFICATION PURSUANT TO N.J.S.A. 5:12-85.1 AND N.J.A.C. 13:69C-2.6 AND 2.7 TO PERMIT HIM TO PERFORM THE DUTIES AND EXERCISE THE POWERS OF VICE PRESIDENT OF HOSPITALITY FOR MARINA DISTRICT DEVELOPMENT COMPANY, LLC WITHOUT FIRST BEING QUALIFIED (PRN 0402101)

WHEREAS, Marina District Development Company, LLC, ("MDDC"), holder of a casino license and doing business as Borgata Hotel Casino & Spa ("Petitioner"), having filed a Petition on February 9, 2021, which Petition was amended by Letter dated February 12, 2021, seeking approval of the New Jersey Casino Control Commission ("Commission") to permit Anthony Caratozzolo, prior to his plenary qualification, to perform the duties and exercise the powers of Vice President of Hospitality of MDDC for a nine-month period in accordance with the conditions contained in N.J.S.A. 5:12-85.1 and N.J.A.C. 13:69C-2.6; and

WHEREAS, Petitioner also seeks the issuance of a temporary casino key employee license to Anthony Caratozzolo pursuant to N.J.S.A. 5:12-89b(4) and -89e; and

WHEREAS, Anthony Caratozzolo filed a Multi-Jurisdictional Personal History Disclosure Form and New Jersey Supplemental Form on February 6, 2021; and

WHEREAS, the Division of Gaming Enforcement ("Division") filed a response to the Petition dated February 16, 2021 in which it indicated no objection to the issuance of a temporary casino key employee license to Anthony Caratozzolo and no objection to him assuming the duties and exercising the powers of Vice President of Hospitality for MDDC prior to plenary qualification; and

WHEREAS, the Division further does not object to the Commission granting the requested relief prior to the expiration of the period specified in *N.J.S.A.* 5:12-89e(2); and

WHEREAS, the Commission considered the entire record of the proceedings at its public meeting of February 19, 2021.

NOW, THEREFORE, BE IT RESOLVED by the Commission that Anthony Caratozzolo be issued a temporary casino key employee license pursuant to *N.J.S.A.* 5:12-89b(4) and -89e and that Anthony Caratozzolo is temporarily qualified and is hereby authorized to perform the duties and exercise the powers of Vice President of Hospitality for MDDC, subject to the conditions contained in *N.J.S.A.* 5:12-85.1 and *N.J.A.C.* 13:69C-2.6.
