VIA NEW JERSEY TURNPIKE

Take the NJ Turnpike to Exit 7. After the tollbooth, bear left to Fort Dix/McGuire Air Force Base exiting the ramp onto Rt. 206 South. Just past the turnpike overpass (Exit 7) on Route 206 South, bear left onto Route 68 South. Follow Route 68 South until you come to the traffic light (entrance to Fort Dix) at the intersection of Saylors Pond Road. Turn left onto Saylors Pond Road. Travel approximately 4.3 miles (Saylors Pond Rd/W. Main Street/ Wrightstown-Cookstown Road) until you come to a stop sign. (New Hanover Township Municipal Complex on corner) Turn right onto Cookstown-Browns Mills Rd. Travel approximately 4 miles until you come to a stop sign. (You will travel through Fort Dix property through the ranges/bivouac area.) Turn right at the stop sign onto Range Rd (no street sign). Travel approximately a mile on Range Road and Mid-State will be on your right.

FROM TRENTON, NEW JERSEY

From Trenton take Route 206 South to Bordentown. Continue on Route 206 South following the signs for the New Jersey Turnpike. Just past the turnpike overpass (Exit 7) on Route 206 South, bear left onto Route 68 South. Follow Route 68 South until you come to the traffic light (entrance to Fort Dix) at the intersection of Saylors Pond Road, Turn left onto Saylors Pond Road. Travel approximately 4.3 miles (Saylors Pond Road/W. Main Street/Wrightstown-Cookstown Road) until you come to a stop sign. (New Hanover Township Municipal Complex on corner) Turn right onto Cookstown-Browns Mills Road. Travel approximately 4 miles until you come to a stop sign. (You will travel through Fort Dix property through the ranges/bivouac area.) Turn right at the stop sign onto Range Road (no street sign). Travel approximately a mile on Range Road and Mid-State will be on your right.

FROM SOUTH JERSEY

Take Route 55 North to Route 42 North to 295 North. Exit 295 North at Exit 40 (Mount Holly/Route 38 East). Follow Rt 38 East through approximately 16 traffic lights. Through the 16th traffic light Route 38 East (Dunkin Donuts, Burger King, Gas Station) will become the Pemberton Bypass, which will bring you to Pemberton-Browns Mills Road/Route 530 (Burlington County College will be on your right). Turn right onto Pemberton-Browns Mills Road (Route 530). At the fourth traffic light turn left on to Trenton Road (Route 545). At approximately 1.8 miles turn right onto Range Road. At approximately one mile Mid-State Correctional Facility will be on your left.

FROM THE SHORE AREA VIA I-195

Take I-195 West to Exit 16 (Mount Holly, Six Flags, Freehold). Upon exiting at the traffic light make a left onto Route 537 West. Follow Route 537 West at 9.3 miles there will be a sign on the right side, which reads "Entering Burlington County." At 9.7 miles turn left on Meany Road. (If you reach the traffic light at the 537 & 528 intersection, you have passed Meany Road.) Follow Meany Road to second stop sign (1.8 miles) at the Y. Bear slightly right onto the Route 528 Spur. travel 4.5 miles (Cookstown-New Egypt Road/Main Street/Cookstown-Browns Mills Road) to the next stop sign. (You will travel through the town of Cookstown onto Fort Dix property through the ranges/bivouac area.) At the stop sign turn right onto Range Road (no street sign). Mid-State will be approximately 1.3 miles on the right.
