Erol Azanli, Brett Hutchinson, Melissa Leto, Theresa Nezezon, Linnea Schiffner, Christine Schlenker and Christopher Szymkowiak appeal the attached decisions of the former Division of Classification and Personnel Management (CPM)¹ that the proper classification of their positions with the Department of Law and Public Safety is Forensic Scientist 1. The appellants seek Forensic Scientist 2 classifications. Since these appeals involve similar issues, they have been consolidated herein.

The record in the present matter establishes that at the time the appellants filed their requests for classification review, they were serving in the title Forensic Scientist 1. The appellants' positions are located in the Division of State Police and do not have any supervisory duties. The appellants sought reclassification of their positions, contending they would be more appropriately classified in the title Forensic Scientist 2. In support of their requests, the appellants submitted Position Classification Questionnaires (PCQs) detailing the different duties that they performed. CPM reviewed all of the documentation supplied by the appellants, including their PCQs. Based on its review of the information provided, including the unit organization chart, CPM concluded that the appellants' positions would be properly classified as Forensic Scientist 1.

It is noted that, except for Ms. Schiffner, the appellants had previously sought reclassification of their positions in 2010. In the determinations dated April 9, 2010, SLO found that their positions should be reclassified as Forensic Scientist 2 and the appellants were provisionally appointed to that title effective June 20, 2009. Subsequently, the appointing authority contacted this agency in November 2010 and requested that the job specification for Forensic Scientist 2 be revised in order to more clearly distinguish what constitutes complex cases, which would be inappropriate for an incumbent in the Forensic Scientist 1 title. Accordingly, the job specification was revised effective January 15, 2011. As a result of this revision to the job specification, the appointing authority removed the complex duties that the appellants had been assigned and returned them to their permanent titles of Forensic Scientist 1 effective January 29, 2011.

On appeal, the appellants assert that they are regularly assigned to complete complex and complicated work on an out-of-title basis that otherwise would be performed by employees serving as a Forensic Scientist 2. The appellants add that such work has continued to be assigned despite the fact that the job specification for Forensic Scientist 2 changed in January 2011. In this regard, they argue that their current assignments include kinship analysis, complex mixture analysis, complex statistical analysis, and rush/expedite cases. In addition, the appellants contend that the job specification for Forensic Scientist 2 does not indicate that supervision of employees, including preparation of employee They add that, except for one evaluations, is a requirement of the position. employee, none of the other individuals serving as Forensic Scientist 2 are responsible for completing employee evaluations. Moreover, Mr. Hutchinson, Ms. Leto, Ms. Schiffner, Ms. Schlenker and Mr. Szymkowiak argue that they are responsible for training individuals who were recently appointed to Forensic The appellants also assert that an on-site desk audit should be conducted. In support of their arguments, the appellants provide a list of cases with descriptions which they argue evidence that they complete complex and complicated work.

CONCLUSION

The definition section of the job specification for Forensic Scientist 2 states:

Under the general direction of a Forensic Scientist 3 in the Department of Law and Public Safety, conducts the more difficult and specialized work involved in the chemical analysis of various matter, substances, specimens, and materials submitted to the laboratory by law enforcement agencies and Medical Examiners Offices for identification in connection with criminal investigations and prosecutions; may supervise or provide guidance to Forensic Scientist 1, Chemists, Laboratory

Technicians, or other laboratory personnel; may function as a Laboratory Information Management System (LIMS) Coordinator, Laboratory Safety Representative/Coordinator, or Quality Assurance (QA) Coordinator of a discipline; performs related field and laboratory work as required.

The definition section of the job specification for Forensic Scientist 1 states:

Under the general direction of a Forensic Scientist 2 or 3 in the Department of Law and Public Safety, conducts the chemical analysis of various materials and evidence submitted to the laboratory by law enforcement agencies and Medical Examiners Offices for identification in connection with criminal investigations and prosecutions; performs related field and laboratory work as required.

A review of the record clearly shows that CPM appropriately found that the proper classification of the appellants' positions is Forensic Scientist 1. On appeal, the appellants argue that they are performing the duties of a Forensic Scientist 2 on an out-of-title basis. Specifically, they argue that they train new employees and perform complex and complicated work such as kinship analysis, complex mixture analysis, complex statistical analysis, and rush/expedite cases. However, a review of the record indicates that the preponderance of the appellants' duties do not include conducting the more difficult and specialized work involved as required, nor do they supervise other personnel or function as a coordinator. determined, the appellants' duties include receiving biological evidence from crime scenes; conducting DNA analysis; extraction, quantitation, purification, and amplification tests on physical evidence; preparing and issuing detailed reports containing findings of analysis; testifying in legal proceedings as an expert witness; providing clear explanation of DNA analysis and contents of reports; and maintaining and generating laboratory reports. These duties are commensurate with a Forensic Scientist 1. Additionally, the Division Director confirmed that these duties are the typical duties of a Forensic Scientist 1. While the Division Director noted that some assignments occasionally become more complex after analysis, he emphasized that the appellants do not routinely work on complex cases. In this regard, the fact that some of an employee's assigned duties may compare favorably with some examples of work found in a given job specification is not determinative for classification purposes, since, by nature, examples of work are utilized for illustrative purposes only. Moreover, any duties which could be otherwise considered out-of-title, such as training were, according to the appellants' PCQs, performed only a very small percentage of time. It is not uncommon for an employee to perform some duties which are above or below the level of work which is ordinarily performed. For purposes of determining the appropriate level with a

given class, and for overall job specification purposes, the definition portion of the job specification is appropriately utilized.

Regarding the appellants' arguments that an on-site desk audit was not conducted, classification reviews are typically conducted either by paper review, based on the duties questionnaire completed by the employee and supervisor; an on-site audit with the employee and supervisor; or a formal telephone audit to obtain clarifying information. See In the Matter of Richard Cook (Commissioner of Personnel, decided August 22, 2006). In this matter, the method of review was appropriate and the appellants have not demonstrated that the review was deficient in any way. Accordingly, there is no basis to disturb the determination of CPM that the appellants' positions are properly classified as Forensic Scientist 1.

ORDER

Therefore, it is ordered that these appeals be denied.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
