(PS6875I), State Parole Board

List Extension

The State Parole Board requests that the eligible list for Hearing Officer 1 (PS6875I), be revived and extended for one year beyond its original expiration date.

By way of background, the subject eligible list promulgated on August 30, 2012 and expired on August 29, 2015. One appointment was made from the only certification that was issued. At its expiration, the names of 30 eligibles remained on the list.

In the instant request, the appointing authority states that it intends to make permanent appointments for vacancies that have resulted through attrition. It is noted that the Division of Agency Services (Agency Services) indicates its agreement with the appointing authority's request. It states that the filling of a vacancy from the subject list is preferable to, and more expedient than, announcing a new examination at this time.

CONCLUSION

N.J.S.A. 11A:4-6 and *N.J.A.C.* 4A:4-3.3(b)1 provide that an eligible list may, for good cause, be extended, except that no list shall have a duration of more than four years. *N.J.S.A.* 11A:4-6 and *N.J.A.C.* 4A:4-3.4 provide that an eligible list may be revived in order to implement a court order or decision of the Civil Service Commission (Commission) in the event of a successful appeal instituted during the life of a list, to correct an administrative order, or for other good cause.


In the present matter, the appointing authority contends that it intends to make permanent appointments for vacancies that have resulted through attrition. Moreover, Agency Services recommends extending the subject eligible list and states that the filling of a vacancy from the subject list is preferable to, and more expedient than, announcing a new examination at this time. Therefore, under these circumstances, good cause has been established to revive and extend the eligible list for Hearing Officer 1 (PS6875I), State Parole Board for one year or until a new list is available, whichever occurs first.

ORDER

Therefore, it is ordered that this request be granted and the eligible list for Hearing Officer 1 (PS6875I), State Parole Board be revived and extended until August 29, 2016 or until a new list is available, whichever occurs first.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
