Raymond Nelson appeals the determination of the Division of Agency Services (Agency Services), which found that he was ineligible for the promotional examination for Sheriff's Officer Lieutenant (PC2094U), Essex County.

The subject examination was open to employees who had an aggregate of one year of continuous permanent service in the Sheriff's Officer Sergeant title as of the November 21, 2016 closing date. A total of 22 employees applied for the examination and 20 were admitted to take the test. The test administration date was May 4, 2017. The appellant's personnel record indicates that he was permanently appointed as a Sheriff's Officer Sergeant effective November 30, 2015. Thus, Agency Services found the appellant ineligible as he lacked the required amount of permanent service as of the closing date.

On appeal, the appellant presents that the test administration date for the Sheriff's Officer Sergeant (PC2153R) promotional examination was on May 8, 2014. However, due to his sister's death, he requested to take a make-up examination, which was granted. The appellant took the make-up exam on May 7, 2015 and received a passing grade. He presents that he was the first ranked eligible on certification PL151294 and was appointed as Sheriff's Officer Sergeant effective November 30, 2015. The appellant asserts that he would have been appointed as a Sheriff's Officer Sergeant on a prior certification if he had been able to take the test for that title as originally scheduled. As he is only nine days short of the time in grade requirement for service as a Sheriff's Officer Sergeant for the subject

examination, he requests that he be determined eligible for the subject examination and be allowed to take the test on the grounds that his delay in his promotion to Sheriff's Officer Sergeant was due to the unfortunate passing of his sister.

## CONCLUSION

N.J.A.C. 4A:4-2.6(a)1 provides that applicants for promotional examinations must have one year of continuous permanent service for an aggregate of one year preceding the closing date in a title or titles to which the examination is open.

N.J.A.C. 4A:2-1.1(b) provides that unless a different time period is stated, an appeal must be filed within 20 days after either the appellant has notice or should reasonably have known of the decision, situation, or action being appealed.

Initially, it is noted that, on May 28, 2014, the appellant signed an Agreement to Take a Make-Up Examination for Sheriff's Officer Sergeant The agreement stated that candidates who passed the make-up examination will be considered for prospective appointment and will not receive retroactive appointments. Therefore, the appellant was on notice that he would only receive a prospective appointment if he passed the make-up exam and should have filed an appeal within 20 days of May 28, 2014 if he believed he was entitled to an earlier appointment based on his circumstances. Additionally, the Civil Service Commission (Commission) notes that the requirement that applicants must have completed one-year in a lower position does not contradict the constitutional mandate that employees be promoted "according to merit and fitness" but only sets a reasonable floor at which the Commission begins to evaluate the qualifications of applicants. The Constitution does not mandate that all promotional opportunities be made available to all employees. Therefore, while the circumstances are unfortunate, the year in grade requirement cannot be relaxed as the appellant must have actually served in and performed the duties of the Sheriff's Officer Sergeant title during the requisite year in grade in order to be eligible. See In the Matter of Peter Corbo, Docket No. A-2275-12T2 (App. Div. October 20, 2014). See also In the Matter of Albert Giordano (MSB, decided January 26, 2005).

Accordingly, based on the foregoing, the appellant has not met his burden of proof, and has not provided a basis to disturb the determination of the Division of Agency Services.

# <u>ORDER</u>

Therefore, it is ordered that this appeal be denied.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
