# **DEPARTMENT OF THE TREASURY**

The Department of the Treasury requests the re-activation of a department-specific title for use in the Division of Property Management and Construction.

The re-activated title is intended to classify staff performing para-professional tasks associated with property management services. It will serve as a para-professional bridge title between the non-professional support title, Technical Assistant 3, and the entry-level professional title, Property Management Services Specialist 4.

The Department requests a concurrent title name, class code and workweek change. The name change is requested to appropriately identify this title as the para-professional level of the series.
