**Description of Incident**: On 11/8/12, the resource parent, Haicel Lazala-Krohn, reported that she left A.C. on the bed and went to retrieve some items in the bathroom. Upon her return, she claimed that A.C. was unresponsive. 911 was called and A.C. was transported to the hospital. While in the hospital, A.C. went into cardiac arrest and efforts to resuscitate her were unsuccessful. A.C. passed away as a result of her injuries on this date. The medical examiner completed an autopsy which noted the cause of death as a "Homicide" and the Manner of deathas " Subarachnoid hemorrhage due to Head trauma." Neither Ms. Lazala-Krohn nor the other resource parent, Lucrecia Vega were able to offer a plausible explanation as to how A.C. became injured. CP&P completed a Child Protection Service (CPS) investigation and substantiated both Ms. Lazala-Krohn and Ms. Vega for physical abuse and neglect/child death.

Once she awakened, she noticed that A.P. was lying on the couch and appeared to be unresponsible. A.P.'s mother contacted 911 and he was transported to the hospital. Efforts to resuscitate A.P. were unsuccessful, and he passed away on this date. The Bergen County Medical Examiner noted evidence of a toxicology report which revealed that A.P. had enough fentanyl in his blood stream to suppress his respiration. A.P.'s mother has Multiple Sclerosis and used a fentanyl patch for pain. CP&P completed a Child Protection Service (CPS) investigation and substantiated A.P.'s mother for neglect/child death.
