The Department of Environmental Protection's Solid and Hazardous Waste Management Program is in receipt of the April 29, 2008 proposed amendment to the Atlantic County District Solid Waste Management Plan (County Plan). The amendment to the County Plan proposes County Plan deletion of the following facilities:

- Chambers Transfer Station in the Township of Egg Harbor;
- Northfield Compost Facility Burton Avenue (leaves) in the City of Northfield;
- Northfield Compost Facility Birch Grove Park (leaves) in the City of Northfield;
- ACUA Temporary Recycling Center in the Township of Egg Harbor;
- R&T Castellini Recycling Center in the City of Pleasantville;
- Atlantic County Tire Slicing Facility in the Township of Egg Harbor;
- J.C. Miller Excavating Company in Estell Manor;
- Hamilton Municipal Leaf Composting Facility in the Township of Hamilton;
- ACUA Enclosed Composting Facility in the Township of Egg Harbor;
- Joe's Auto Wreckers Tire Recycling Facility in the Township of Hamilton;
- Lafayette Utility Company Class B Recycling Center in the Township of Egg Harbor;
- Magic Disposal Class A Recycling Center in the Township of Egg Harbor;
- 3031 Ocean Heights Avenue Class B Recycling Center (Arthur Henry) in the Township of Egg Harbor;
- Anchor Disposal Transfer Station in the Township of Egg Harbor.

Although initiated as a plan amendment, as per N.J.A.C. 7:26-6.11(b) 7, the deletion of any facility which is included in the plan for more than two years but for which a complete permit application has not been made, or deletion of any facility which is included in the plan but has not been in operation for more than two years can be accomplished via an administrative action. Therefore, the County Plan deletion of facilities is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
