Dear Mr. Lefke:

The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a request for administrative action to the Atlantic County District Solid Waste Management Plan (County Plan) dated May 1, 2018. This request for administrative action to the County Plan proposes County Plan inclusion to modify three (3) Egg Harbor Township owned parcels of land along with the portions of a few roadways located adjacent and within the property currently owned and operated by the Atlantic County Utilities Authority (ACUA), be given to the ACUA and implemented without compensation to the Township.

In summary, the following parcels given to ACUA and the associated roadways that have been vacated are included in the County Plan:

- Lot 16 (5.61 acres) in Block 605 which is adjacent to Lot 17, 18 and 19.
- Lot 18 (3.63 acres) in Block 703 which is adjacent to Lot 4 and Lot 6.
- Lot 20 in Block 703.
- Block 603, Lots 10 to 13; Block 604, Lots 1 & 2; Block 605, Lots 1 to 5, 16 to 19; Block 606, Lots 1 & 2; and Block 607, Lots 5 to 8 would become Block 603, Lot 10.
- Vacate Disston Street and portions of Pleasant, Summit and Risley Avenues.


The Township would also like to consolidate Lots 1 to 8, 18, 19, and 20 within Block 703, as Block 703, Lot 1; and consolidate Lots 3, 4, 5, and 10.01 within Block 704, as Block 704, Lot 3.

- The ACUA property within Block 704, Lots 6,7,8, and 9 will remain separate.

Pursuant to N.J.A.C. 7:26-6.11(b)14, change in lot and block designations at an existing solid waste facility can be accomplished through an administrative action. Therefore, the County Plan inclusion to modify ACUA's lot and blocks and vacate roadways is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
