Dear Mr. Marturano:

The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a July 22, 2020 request for administrative action to the New Jersey Sports & Exposition Authority District Solid Waste Management Plan (District Plan). This request for administrative action proposes District Plan inclusion of:

- Revised block and lot designations, and;
- Modification of operating hours at the Westside Transload, LLC Transfer Station/Materials Recovery Facility (TS/MRF) located at 5600-5800 Westside Avenue in the Township of North Bergen.

Specifically, the original District Plan included documentation for the property listed Block 453A, Lots 5A1, 5B, 5C, and part of Lot 7C and Block 481, Lot 1. Due to the Township of North Bergen re-designating the parcels comprising the Facility on its Tax Map, the revised designation is Block 485, Lots 3 and 3.01. Additionally, the modified operating hours listed in the July 22, 2020 request for administrative action are as follows:

- Acceptance of waste: Monday through Saturday, 24 hours per day until such time that Westside Transload, LLC TS/MRF reaches 700 tons per day (tpd). Upon reaching 700 tpd, material acceptance will be from the hours of 9 a.m. – 7:00 p.m. and 9:00 p.m. – 7:00 a.m., Monday through Saturday with the exception of select major holidays when 24 hours of material acceptance is authorized.
- Processing and transferring of waste: Monday through Saturday, 24 hours per day

The District Plan inclusion of the above noted changes in the block and lot designation and the modified operating hours at the Westside Transload, LLC TS/MRF will not result in any operational changes at the facility.

Pursuant to N.J.A.C. 7:26-6.11(b)14, a change in the block and lot designation and the modification of operating hours of an existing solid waste facility can be accomplished via an administrative action. Therefore, the District Plan inclusion of changes in the block and lot designation and the modification of operating hours at the Westside Transload, LLC TS/MRF are hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
