As the Volunteer Advocacy Vice President for the New Jersey Association for Gifted Children, I have dedicated over forty years of my professional and personal time to defend the rights of gifted students in New Jersey. I have worked with the Department of Education through many administrations and with the NJ legislature and US Congress, and will continue to pursue initiatives to assure an appropriate education for the 160,000+ gifted students in our schools, whose academic and social emotional needs go mostly unattended. Several of my past testimonies to this board can be found online on the DOE website. None of my requests have been addressed or answered.</p> <p>Today I have five very specific “asks” and goals:</p> <ol style="list-style-type: none">1. NJAGC leaders want a face to face meeting with the new Commissioner of Education.2. NJAGC requests that this State Board of Education makes gifted education a priority in its strategic planning goals.3. NJAGC offers our help to the NJ Department of Education to give guidance to local district leaders to identify and provide a continuum of services to gifted students K-12, as per administrative code. This has not been done since 2005, causing a crisis for our schools.4. NJAGC is providing current research to assess and address the poor performance of NJ’s schools with regard to the Excellence Gap, which shows limited access to students in poverty to gifted services. It is imperative that we find and nurture these students from an early age to develop their academic talents. Two districts in New Jersey have recently been cited by the US Office of Civil Rights. NJAGC is requesting that a Gifted Education Advisory board be established by the Department of Education, to investigate and evaluate current practices and recommend changes and improvements. This group should have representation from across the state with educators, parents, and university specialists. <p>So, please do all in your power as an appointed member of the State Board of Education to assure that ALL children have an appropriate education in our New Jersey schools, including those who are performing above the standards, whose time in school is often wasted, and whose teachers and administrators require more education to meet the academic and social emotional needs of our gifted students.</p>
