ORGANIZATIONAL CHART

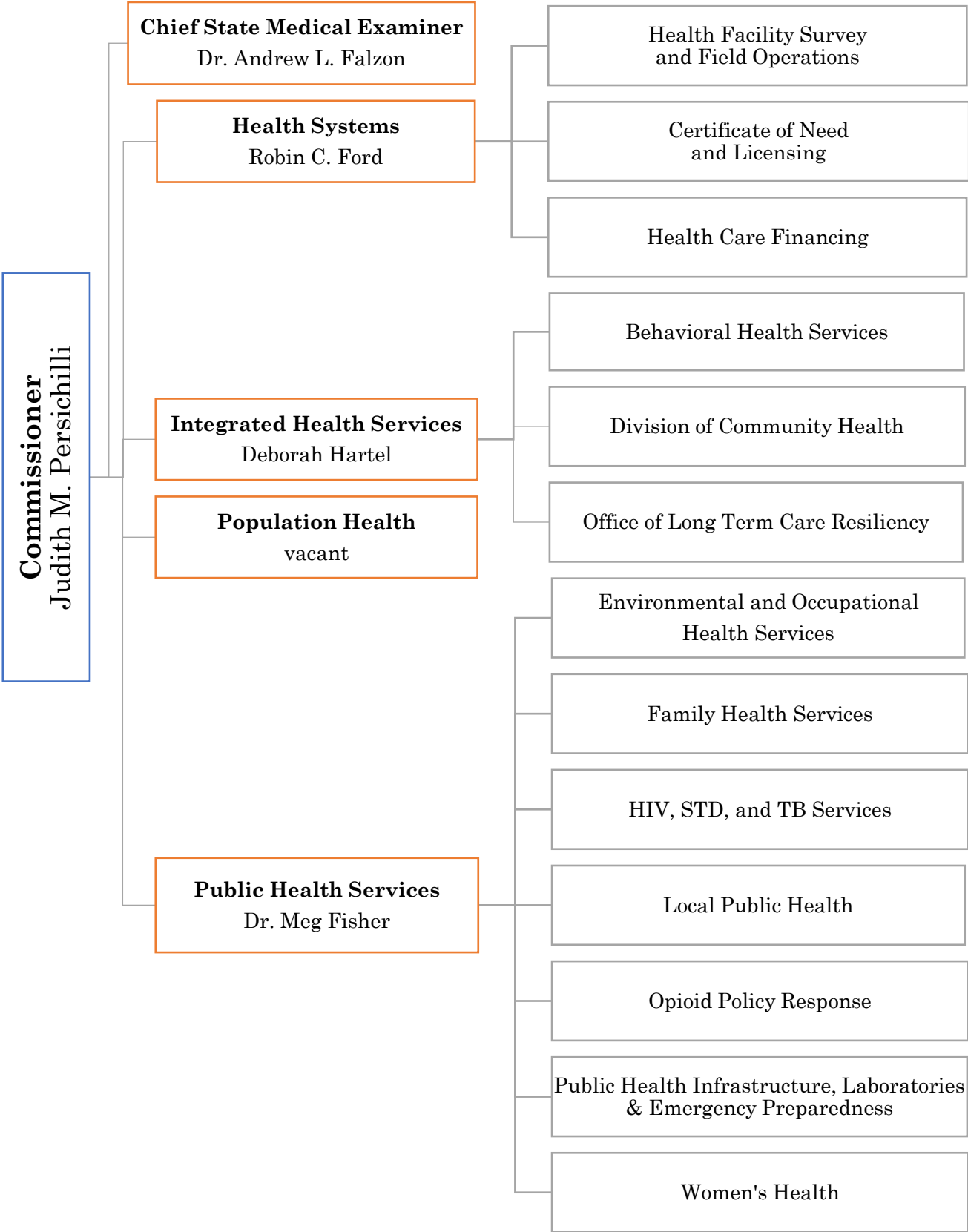
