SUBJECT: Tax Year 2006 Earned Income Tax Credit Campaign

As you may be aware, the Tax Year 2006 Earned Income Tax Credit (EITC) Campaign is now in progress. In conjunction with the Division of Family Development and your agencies, we have participated in the outreach efforts in the past to inform beneficiaries about the availability of the earned income tax credits. We appreciate your efforts and again seek your assistance with this year's campaign.

Attached is the EITC bilingual flyer that we are requesting be made available in your waiting room and to individuals utilizing your hospital outstationing sites. We also ask that you include a flyer when mailing out applications for the NJ FamilyCare program. The flyer provides basic information about the benefit and provides the telephone numbers and website addresses to contact for further information. Please feel free to duplicate them as needed for distribution.

EITC is a special tax benefit for certain low-income individuals who work full or parttime, reducing tax liability that may or may not result in a payment to the taxpayer. In addition to the Federal EITC, a New Jersey EITC is available to certain low-income working parents. For purposes of Medicaid and NJ FamilyCare eligibility, EITC payments are considered to be exempt from countable income.

Volunteer Income Tax Assistance (VITA) centers will be operating throughout the State to provide free assistance in completing the necessary tax forms. 


