Executive Summary

The State of New Jersey has come a long way in a relatively short time with regards to seat belt usage. As recently as 1996 the seat belt usage rate in New Jersey stood at 60%. The New Jersey Division of Highway Traffic Safety is pleased to report that through the Click It or Ticket 2006 Statewide Mobilization, the usage rate rose for the tenth consecutive year, to 90%.



Seat belt usage remains the most effective way for a motor vehicle occupant to avoid death or serious injury in a crash. It reduces a motor


vehicle occupant's risk of fatal injury by 45% and moderate or critical injury by 50%. The effort to convince the motoring public to "buckle up" began 40 years ago in 1966, when Congress enacted the Federal Highway Safety Act, which, among other things, required auto-makers to equip all vehicles with lap seat belts. In the years since, government has worked successfully with the traffic safety community and law enforcement agencies to enhance seat belt usage nationwide through additional requirements for car manufacturers, mandatory use laws, and concerted enforcement and educational campaigns.



The most recent example of a comprehensive seat belt program was the Click It or Ticket 2006 Statewide Seat Mobilization. The mobilization ran from May 22 through June 4, 2006.

Key components of the Click It or Ticket 2006 Statewide Mobilization included targeted seat belt enforcement and education by 441 police agencies in the state, 159 of which received Click It or Ticket grants from the Division. Awareness about the campaign was further enhanced by the distribution of materials to partner agencies statewide.

Three kickoff events were held to launch the Click It or Ticket 2006 Statewide Mobilization. The program was announced at the statewide "101 Safe Driving Days of Summer" event on May 16, 2006 on the Boardwalk in Seaside Heights. The enforcement phase of the program began with a pair of operations on the morning of May 22, 2006: At the George Washington Bridge in Fort Lee, conducted by the Bergen County Police Department; and on Route 130 in Gloucester County, conducted by the Gloucester City Police Department.





The following are highlights of Click It or Ticket 2006 mobilization effort:

- Letters of invitation were sent to all 473 police agencies in the state.
- Staff from the Division called each police agency to confirm receipt of the correspondence and to elicit participation in the mobilization.
- A total of 441 police departments participated in the two-week enforcement mobilization, the largest number ever.
- 159 municipal police departments received Click It or Ticket grants and participated in the two-week mobilization.
- More than 56,000 seat belt summonses were issued statewide during the two-week campaign.
- 27 police agencies issued more than 400 summonses during the two-week campaign, up from 18 in 2005.
- The New Jersey Institute of Technology conducted a post-mobilization seat belt survey following the campaign. Results of the survey indicate that the seat belt usage rate in New Jersey rose for the 10th consecutive year, to an all-time high of 90%.
- Comparisons of pre and post-surveys conducted by Click It or Ticket grant-funded agencies shows that seat belt usage rose in 93% (131 of 141) of the grant-funded municipalities that conducted both of the surveys.
- Participation in the 2006 campaign increased as compared to 2005, despite a 50% reduction in federal funding for the program and a 40% reduction in the number of grantees the Division was able to fund.
- The seven-county North Region (Bergen, Essex, Hudson, Passaic, Morris, Warren and Sussex) achieved 100% participation in the mobilization (185 of 185 police agencies reporting). Also achieving 100% participation were Atlantic, Camden, Cape May, Cumberland, and Salem counties.

In conclusion, the Click It or Ticket 2006 Statewide Mobilization provided the Division the opportunity to partner with more police agencies than ever before in a comprehensive seat belt enforcement and education campaign. Survey results show that seat belt utilization rose significantly, to an all-time high, as a result of this program.

I. Methodology

Planning for the Click It or Ticket 2006 Statewide Mobilization began in late 2005, when the Division of Highway Traffic Safety Director, Deputy Director, and Region Supervisors agreed on a detailed plan of action and timeline for the campaign. The plan of action was used to carry out all components of the mobilization, including the development and distribution of educational materials, the soliciting and processing of grant applications, outreach to all police agencies to secure participation in Click It or Ticket, and the media awareness component of the program.

All 473 police agencies in New Jersey were asked to participate in the Click It or Ticket 2006 Statewide Mobilization, on either a funded or non-funded basis. Based on available funding levels, 159 departments were offered Click It or Ticket grants to support efforts locally. Along with the letters of invitation, grant packet, and educational materials, each department received a mobilization enforcement reporting form to be filled out and returned prior to June 16, 2006.

The outreach efforts carried out by DHTS staff members proved to be successful, as 441 police agencies ultimately participated in the campaign, an increase from 2005. Participation by a police agency took the form of either enforcement or educational/awareness activities. Only 32 police agencies did not participate in the 2006 campaign, which is an improvement when compared to the 39 agencies that did not participate in 2005's campaign. A list of the non-participant agencies is included in the Appendix.

As the result of this concerted effort to elicit participation from the local departments, the response to the mobilization effort was greater than ever before. A total of 441 police departments participated. This represents 93.2% of the total local police agencies in the state. This rate, too, is an increase compared to the overall participation rate of 91.7% in 2005.

159 municipal police agencies received grant funding for the Click It or Ticket 2006 Statewide mobilization. The grant paid for 80 hours of overtime patrols during the two-week period of May 22 through June 4. Officers on these overtime patrols were charged with enforcing existing motor vehicle codes, with particular emphasis on the occupant protection statutes relating to seat belts and child safety seats.

In addition, two sets of observational surveys on seat belt usage by motor vehicle drivers and occupants were done to capture the effect of the mobilization. One was done statewide by the New Jersey Institute of Technology and the other was done by the 159 Click It or Ticket grantees. Each set of surveys was conducted before and after the mobilization.





III. Analysis of the Data


The success of any traffic safety effort depends greatly on highly visible enforcement. In Click It or Ticket, these enforcement efforts include the issuance of citations to motorists that do not wear a seat belt and to drivers who do not properly restrain their children. It is clear from the results of these enforcement efforts that the campaign was a success: Results from statewide observational survey conducted immediately after the mobilization show a seat belt usage rate in New Jersey of 90%, an increase of four percentage points from 2005, and the 10th consecutive annual increase in the rate.

The table that follows summarizes the results of the enforcement component of the campaign. During the two-week Click It or Ticket 2006 Mobilization, the 441 participating police departments issued 56,360 seat belt citations, 917 child restraint citations, and 56,992 other citations.

The statewide seat belt usage rate increased by four percentage points from 86-percent pre-mobilization to 90-percent post-mobilization. For the surveys, NJIT staffers conducted observations at 225 locations in 13 of New Jersey's 21 counties. The locations selected included a variety of roadway types including interstates, local roads, and major and minor arterial roadways in both urban and rural areas. The following table presents the results of the pre and post-mobilization surveys.

In addition, 141 sets of pre and post-surveys received from Click It or Ticket grant-funded agencies indicate an increase in seat belt usage in those municipalities. Of the 141 reports received, 131 (93%) showed increased seat belt usage in the post-mobilization survey, five showed a decrease and five were unchanged.

INTRODUCTION

This report documents the results for the data collected both prior to and after the "Click-It or Ticket" campaign. Information on the study design and data collection for determining the seat belt usage rates were provided in the "Seat Belt Usage Study for New Jersey: Pre-Campaign Report", June 2005 and included in Appendix I of this report. The procedures used in collecting the seat belt usage rates follow the guidelines provided in the *Uniform Criteria for State Observational Surveys for Seat Belt Use*. These guidelines dictate how the data were collected, the sample size, how collection locations were identified and the analysis approach.

Seat belt usage for drivers and front seat outboard passengers in passenger motor vehicles was observed in the survey. Seat belt usage was obtained separately for four passenger motor vehicle types including: passenger cars, pickup trucks, vans and sport utility vehicles(SUVs). Data were also collected separately for drivers and for front seat outboard passengers.

The data collected includes the use or non-use of a shoulder belt. Data were collected through direct observation of seat belt use on roadways within the State at intersections and at freeway interchanges. Data were collected both before and after the "Click-It or Ticket Campaign". The pre-campaign data collection occurred from April 1st, 2006, until May 8th, 2006. The post-campaign data collection occurred from June 6th, 2006 to July 10th, 2006.

Preliminary analysis indicated that 250 observations would provide results within the allowable relative error. The pre-campaign data collection showed that although the overall Statewide usage rates had relative errors within five percent, some usage rates calculated for front seat passengers by functional classification had higher relative errors than desired. For this reason, the number of observations made during the post-campaign data collection was increased from 250 observations to 350 observations for each of the study locations.

SURVEY DATA ANALYSIS

The collected data were used to provide an overall restraint usage rate for the State of New Jersey. Table 1 shows the usage rate for surveyed drivers and passengers both before and after the "Click-It or Ticket" Campaign. Overall, 89.34% of surveyed front-seat occupants (both drivers and passengers) used a safety belt in the post-campaign survey compared to a usage rate of 84.25% in the pre-campaign survey. This resulted in a percentage increase of 5.09% in usage rate as a result of the campaign. Drivers had a higher rate of safety belt usage with a usage rate of 89.74% in the post-campaign survey compared to a usage rate of 85.46% in the pre-campaign survey. This resulted in a percentage increase of 4.28% in usage rate as a result of the campaign. The passenger usage rate in the post-campaign survey was 86.65% compared to 76.64% in

the pre-campaign survey. This resulted in a percentage increase of 10.01% as a result of the campaign.

Restraint use was also determined for each vehicle type surveyed (passenger cars, pickup trucks, vans, and sport utility vehicles). Table 1 shows the usage rate for drivers and passengers for each vehicle type. As the table shows, passenger cars have the highest overall usage rate in the post-campaign survey of 91.21% followed by sports utility vehicles (SUV) with a usage rate of 91.04%. SUV passengers, however, have a higher usage rate than passenger vehicle passengers. The usage rate for SUV passengers is 89.65% compared with the usage rate for passenger car vehicles of 88.47%. Pick-up truck front seat occupants have the lowest usage rate with a rate of 77.08% and vans have a usage rate of 88.93%.

The largest increase in usage rate from the pre-campaign to the post-campaign period among vehicle types was the increase for front seat passenger, driver and front seat occupant for pick-up trucks. The increases for these groups are 9.20%, 15.02%, and 10.15%, respectively. The smallest increase was the increase for sports utility vehicle drivers with an increase of 3.50%.

Table 1 also provides the usage rates for the pre- and post-campaign period obtained in 2005. As the table shows, the usage rates obtained in 2006 are significantly higher than those obtained in the pre-campaign survey in 2005. In 2005, the front seat occupant post-campaign survey usage rate was 85.47%, which is 2.62% lower than the front seat occupant post-campaign survey usage rate for 2006. Pick-up trucks and vans experienced a higher increase in the front seat occupant post-campaign seat belt usage rate from 2005 to 2006 of 7.92% and 7.71%, respectively. Passenger cars and SUVs experienced a slightly lower increase, with an increase of 3.13% and 2.43%, respectively.

Weighted Usage Rate

The usage rates shown in Table 1 are rates for a sample of drivers and passengers in the State of New Jersey. To determine the overall State usage rate, the sample data were weighted by vehicle-miles-traveled (VMT). To determine the overall State usage rate, the weighted county usage rate was first determined using the following expression:

VMT was not available for each roadway where data were collected. The overall VMT for each functional classification roadway in each county was instead used to determine the weighted county usage rate. The VMT used is provided in Appendices III and IV.

Weighted usage rates for front seat occupant, driver and front seat passenger by county are determined and shown in Tables 2, 3 and 4, respectively. Usage rates are determined for all counties where data were collected, as no data are available on the usage rate for the counties not surveyed. Using the weighted usage rate by county, the overall weighted State usage rate is determined as follows:

Using this equation, the overall front seat occupant, driver and front seat passenger State usage rates are determined as 89.97%, 90.30% and 87.70% respectively. For front seat occupants the usage rate increased by 5.50% from 84.47% in the precampaign survey. Driver usage rates increased by 4.72% from 85.58%, and front seat passengers increased by 11.07% from 76.63%.

The 95 percent confidence interval for the usage rates were also calculated as follows:

where n is the sample size with the confidence bounds for the State usage rates provided in Tables 2, 3 and 4.

To comply with NHTSA guidelines, the survey was designed so that the relative error, or the standard error divided by the sample estimate, for safety belt use will not exceed five percent. In general, a total of between 250 and 350 observations were collected at each location. This number of observations was believed to be adequate to provide a sample size that will produce a relative error of less than five percent at most locations. The relative error for each usage rate is provided in Tables 2, 3 and 4.

Comparison of 2005 and 2006 County Usage Rates

Table 5 shows the difference between the 2006 and 2005 post-campaign weighted usage rates by county. The Table shows an increase in the usage rate of the front-seat occupant, driver and front-seat passenger of 4.50%, 3.18% and 11.56%, respectively from 2005 to 2006. This increase varies from county to county with Union county experiencing the highest increase in the front seat occupant, driver and front seat occupant usage rate of 10.59%, 9.54% and 20.02%.

Usage Rate by Functional Classification

Usage rates by functional classification were also determined and are shown in Tables 6, 7 and 8. Table 6 shows the overall usage rate for front-seat occupants, Table 7 shows the usage rate for drivers, and Table 8 shows the usage rate for front-seat passengers. As the Tables show, for front-seat occupants and drivers, the highest usage for the post-campaign occurred on Urban Principal Arterials with a usage rate of 97.28% for front seat occupant and 97.37% for drivers. The lowest usage rate was on Rural minor collector roadways with a usage rate of 84.73% for front seat occupant and 84.57% for drivers. Rural Minor Collector roadways also had the only reduction in usage rate of 4.09% from the pre-campaign to the post-campaign survey for front seat occupant and a reduction of 4.62% for drivers. Urban Principal Arterials had the highest increase in usage rate of 10.75% from the pre-campaign to the post-campaign survey for front seat occupant and 9.56% for drivers.

The highest usage rate for front seat passengers occurred on Urban Principal Arterials with a post-campaign usage rate of 95.86%. The lowest usage rate for this group occurred on Rural Interstate roadways with a usage rate of 82.70%. Like front seat occupants and drivers, there was a reduction in usage rate from the pre-campaign to the post-campaign usage rate for front seat passengers on Rural Minor Collector roadways. A reduction of 0.62% in the usage rate occurred for this group.

Comparison of Post-Campaign Usage Rates by Functional Classification

Table 9 shows the difference between the 2005 and 2006 pre-campaign usage rates by functional classification. The largest difference occurred for front seat passengers on Urban Principal Arterials with an increase in usage rate from 2005 to 2006 of 24.86%. The largest difference in usage rate for front-seat occupant and driver also occurred on Urban Principal Arterials with an increase of 20.25% and 20.00%, respectively. For Rural Minor Collector roadways there was a decrease in the front seat occupant, driver and passenger usage rates of -1.36%, -1.03% and -2.42%, respectively.

IV. Conclusion

It is clear from the results of the Click It or Ticket 2006 Statewide Mobilization that the local law enforcement community in the state is willing to participate in important statewide traffic safety programs, even during times of decreased levels of funding. A larger number of police agencies in the state than ever before embraced the 2006 Mobilization and through the dedicated work of these local officers a very strong message was sent about the importance of seat belt usage.

The large number of occupant protection-related summonses that were issued during the campaign and the resulting increase in the statewide seat belt usage rates proves once again that high visibility enforcement campaigns have a very positive effect on enhancing traffic safety.

The State of New Jersey has come a long way with regards to usage of seat belts. In fact, the state's seat belt usage rate has risen nearly 30 percentage points in the last ten years. It is clear, however, that the work is not complete. For 2007 and beyond the Division must further expand its efforts and funding commitment in order to garner the participation of police agencies that, to date, have not taken part in the campaign and to continue to engage ongoing partners. The strong partnership between the Division of Highway Traffic Safety and New Jersey's law enforcement community will continue to grow and expand in the years ahead with a goal of, once and for all, convincing all non-seat belt users to "buckle up."

Police wrote hundreds of tickets during the Memorial Day weekend as part of the national Click it or Ticket initiative to stress the importance of using seat belts.

Bergen County police alone issued about 1,000 tickets as part of the campaign, which runs through Sunday, said Capt. Kevin Hartnett.

Hackensack police issued about 100 tickets, said Detective Capt. Frank Lomia.

Police agencies statewide participated in the national initiative as part of regular patrols and checkpoints to catch those who don't buckle up.

The state Division of Highway Traffic Safety issued \$4,000 grants to 156 police agencies -- including 27 in Bergen and Passaic counties -- to cover overtime costs.

The Passaic County Sheriff's Department, which received a grant, will not tabulate its numbers until the program concludes, but has seen "a significant increase in summonses," said Bill Maer, a spokesman.

"The publicity about the program has encouraged people to wear their seat belt, which is what this is really about," Maer said.

Using seat belts can reduce fatalities by 45 percent and the risk of moderate to critical injury by 50 percent, according to the National Highway Traffic Safety Administration.

New Jersey has a seat-belt compliance rate of about 86 percent, one of the highest in the nation.

Law enforcement officers throughout New Jersey will be stepping up enforcement and education of the state's Primary Seat Belt Law. The enforcement and education campaign comes as part of the nationwide Click It or Ticket Mobilization.

The goal of the program is to increase the statewide safety belt usage rate to 88 percent. The current safety belt usage rate in New Jersey is 86 percent, and the rate has steadily risen during the last eight years.

In 2005, there were 757 motor vehicle fatalities in New Jersey, a large percentage of

Cops have eyes out for unbucklers

RANDOLPH TWP. - It is a simple gesture that takes only a moment and yet statistics show buckling up saves lives.

Police are concentrating on locating people who do not wear their seat belts while driving or as passengers during the annual "Click It Or Ticket" program that is being held nationwide.

The two-week program began Monday, May 22, and will continue through Sunday, June 4. Both roving patrols and checkpoints will be used in the cam-

Sgt. Will Yarzab, supervisor of the police traffic safety division. said the program has been very successful in past years.

We won't have any numbers until we close the program on June 4, but it seems to be going very well," said Yarzab. "It's about the same pace as last vear.'

During the two-week period in 2005, police issued 567 summonses, including 365 for not wearing seatbelts and two for improper child restraints.

Federal Funding

A \$4,000 grant from the National Highway Safety Agency pays overtime for extra patrols. The effort has a side benefit of providing more stringent enforcement of other traffic safety laws, Yarzab said.

The same two-week period in 2005 resulted in 42 summonses for speeding, five traffic signal violations, 29 equipment violations such as headlights that don't work, and 104 for other non-moving violations.

Yarzab said failure to wear a seat belt is a primary offense, which means police can stop drivers who aren't wearing their belts.

Summonses can result in fines but not points imposed on their driver's license.

"We increased our seat belt usage from 82 percent pre-enforcement to 88 percent post enforcement as a result of this program," said Yarzab.

Yarzab said in his experience older drivers are the worst of fenders of the seat belt law.

"It seems that the very young drivers are wearing their seatbelts, but the older generation who grew up without it being the law are less likely to buckleup," said Yarzab.

But that doesn't mean senior citizens are the worst offenders. Yarzab said adults in their 40s learned to drive before buckling up became mandatory in New Jersey. He said seat belt use later became a part of driver training for younger drivers, making them less likely to forget.


