Please take notice that the New Jersey Motor Vehicle Commission (MVC) has been informed by the New Jersey Department of Banking and Insurance that it has approved the use of out-of-state insurance cards issued by the United Services Automobile Association ("USAA") for New Jersey registered vehicles owned by active duty military personnel. These out-of-state insurance cards are issued based upon insurance policies that meet the mandatory New Jersey insurance requirements. Attached to this notice are several samples of various types of these out-of-state insurance cards.
