WHEREAS, the position of Regional Planner is a non-management position as identified in the organization chart; and

WHEREAS, the Executive Director has advised to the Personnel Committee of the promotion of Carl Figueiredo to the position of Geographic Information System (GIS) Supervisor; and

WHEREAS, the Personnel Committee supports the action of the Executive Director as provided by the bylaws; and

WHEREAS, the Personnel Committee and the Executive Director request affirmation of this action by the full Highlands Council;

NOW, THEREFORE, BE IT RESOLVED

1. The Highlands Council hereby affirms the promotion by the Executive Director of Carl Figueiredo as GIS Supervisor, at an annual basis of \$58,544.
