Content Note

This series consists of deeds, mortgages, agreements and other records relating to real property held by the New Jersey State Village for Epileptics at Skillman. Several documents relate to Maplewood Farm, one of the two original tracts purchased in 1898 for the Village site [items 4-7b and 9-10d]. The records are arranged chronologically with undated material filed at the beginning.

- 8. Lease of S. Olin Garrison to the New Jersey State Village for Epileptics for 213 acres in Montgomery Twp., Somerset Co., 1 November 1898.

Ward, representing the Executive Committee of the New Jersey State Village for Epileptics, 12 April 1900 [signed manuscript copy and signed typed copy]; also note from J. J. Bergen, Counselor at Law, to "My dear Doctor" [probably Dr. Henry Weeks, Superintendent of the Village] regarding the "two old deeds," 24 May 1900 [3 items].

Special contract between the Delaware & Atlantic Telegraph & Telephone Company and the New Jersey State Village for Epileptics for various telephone services and equipment, 19 September 1905; also two applications from the Village for additional facilities and services, 26 May & 8 August 1917 [3 items].
- 13. Agreements giving an option to David F. Weeks to purchase 226 acres "located to the north of the N. J. State Village for Epileptics" from Luther C. Van Zandt [fragment] and land "located to the north of and adjoining the State Village property" from L. C. and S. H. Van Zandt, 11 December 1911 & 19 March 1912 [2 items].
- 14a. Unsigned letter to William T. Read, State Treasurer and Newton A. K. Bugbee, Comptroller of the Treasury, regarding the purchase of portions of the farm of Mr. S. S. Voorhees, December 1917 [probably draft of a letter from Dr. Henry Weeks, Superintendent of the New Jersey State Village for Epileptics].
- 14b. Agreement of S. S. Voorhees to sell 75 acres in Montgomery Twp., Somerset Co., to the State of New Jersey (by William T. Read, State Treasurer, and A. K. Bugbee, Comptroller), 18 December 1917 [signed copy and draft; 2 items].
- 14c. Agreement of S. S. Voorhees to sell 75 acres in Montgomery Twp., Somerset Co., to the State of New Jersey (by William T. Read, State Treasurer, and A. K. Bugbee, Comptroller), 4 November 1918.
- 15. Deed of the State of New Jersey to the Board of Chosen Freeholders of the County of Somerset for a parcel of land belonging to the New Jersey State Village for Epileptics needed to straighten the county road leading from Plainville to Blawenburg, 13 October 1920.
- 16. Letter of F. P. Gerry, Deputy Commissioner, Department of Institutions and Agencies, to Albert W. Pigott, Superintendent of the New Jersey State Village for Epileptics, regarding insurance coverage on Village property, 22 April 1947; also photostatic copy of insurance endorsement for coverage of various buildings of the New Jersey State Village for Epileptics, 15 April 1947 [2 items].
