The New Jersey Department of Transportation (NJDOT), committed to developing transportation improvements that best balance transportation needs, the environment, community concerns and costs, will hold a **Public Information Center** to provide local residents and businesses with information on the **Route 73 and Evesham Road/Marlton Parkway (CR 544) project in Evesham Township, Burlington County**. You are encouraged to actively participate by providing comments at the meeting, by mail, or by e-mail.

The Meeting

The Public Information Center will be held at the **Evesham Township Municipal Building, 984 Tuckerton Road, Marlton on Monday, June 4, 2018 from 6:00 – 8:00**. Please come at a time that is convenient for you. You will have an opportunity to review exhibits of the proposed project, ask questions and discuss any concerns with NJDOT representatives. Property owners with rental units are advised that tenants are also invited and encouraged to participate.

PROJECT BACKGROUND

This project was initiated by the NJDOT Division of Project Management as a result of significant operational, safety, and delay problems identified within the project limits. The project limits are from M.P. 21.95 (south of Sunbird Dr) to M.P. 23.90 (north of Centre Blvd) along Route 73 in Evesham Township, Burlington County.

PROJECT PURPOSE

The purpose of the Route 73 and Evesham Road/Marlton Parkway (CR 544) Concept Development Study is to develop a Preliminary Preferred Alternative (PPA) which improves operational and safety conditions within the project limits with a focus on improvements at the intersections of Route 73 and Evesham Road/Marlton Parkway and Route 73 and Brick Road.

PRELIMINARY PREFERRED ALTERNATIVE

The Preliminary Preferred Alternative (PPA) was selected because it best addresses the established purpose and need developed for the project area and has been viewed favorably by project stakeholders (NJDOT, Burlington County, and Evesham Township).

Specifically, the PPA consists of the following components:

- Three through lanes on Route 73 from just north of Sunbird Drive to just north of Centre Boulevard in both directions.
- Auxiliary lanes provided for right turn and jug-handle vehicles at Ardsley Drive (Target), Evesham Road/Marlton Parkway, and Brick Road.
- Removal of the unsignalized Route 73 southbound left turn onto Commonwealth Drive.
- Conversion of the Marlton Parkway and Sagemore Drive signalized intersection to a single lane modern roundabout.
- Removal of the Route 73 northbound left at Evesham Road. Vehicles will be directed to the proposed Marlton Parkway Roundabout.
- Realignment of the Route 73 southbound jug-handle at Brick Road.
- Substandard curb ramps will be replaced with ADA compliant curb ramps. Additional sidewalk is proposed to complete gaps in the existing sidewalk network.
