

ROUTE 52 CAUSEWAY REPLACEMENT PROJECT COMMUNITY PARTNERING TEAM MEETING NO. 1 REPORT

DATE: December 11, 2002 TIME: 10:00 a.m. - 3:30 p.m. LOCATION: Music Pier Ocean City, NJ

1. PURPOSE OF MEETING

To define the purpose, goals and structure of the Community Partnering Team (CPT); present the current project status and schedule; discuss existing conditions and proposed improvements; and identify community issues and interests. (Agenda and PowerPoint Presentation Slides attached)

2. MEETING SUMMARY

Martine Culbertson, facilitator for the CPT, welcomed everyone to the meeting. She then asked attendees to introduce themselves and state what organization or entity they represent. She introduced Dave Lambert, the NJDOT Project Manager to provide the program overview and direction for the project.

Project Overview:

Dave Lambert provided information on the history for the causeway replacement project along with the Purpose and Need for the project. He noted the important benefits resulting from the Bridge Replacement, such as improved safety, elimination of drawbridges, to elevating the structures so they will not flood and improve access for vehicles. (See slides 1 thru 7 of the attached presentation)

Community Partnering Team (CPT):

Martine then presented the agenda and the goals for the meeting as described above. She conducted a brief exercise to demonstrate the mechanism of working as a team to identify all issues and then through discussion come to agreement. She reviewed the CPT Handbook materials distributed to CPT members at the meeting and asked that they read the information and provide comments. This is a working handbook to assist the members with sharing project information with their constituents. Martine also explained the structure of the CPT and the various components that make up the team, their Roles and Responsibilities. Primarily, the Team is divide into Members, Invited Guests, Alternates and the Steering Committee. Martine then asked members to develop a list of team agreements as a Team Charter or Goals for all team members to follow. They are listed as follows:

- ¥ Safe access for all (pedestrian/bike/vehicle)

- ¥ Compatible aesthetic design consistent with community
- ¥ Enhance public waterfront access

Team Charter:

- ¥ People friendly causeway
- ¥ Complete on timely basis
- ¥ Minimize traffic disruption
- ¥ Maintain fishing access
- ¥ Causeway replacement is an enhancement to both communities
- ¥ Maintain quality of life for residents
- ¥ Maintain business access and circulation
- ¥ Follow environmental process and provide mitigation

Project Status and Schedule:

Mike Sidani, Project Manager from Michael Baker, Jr. then presented the project information starting by briefly discussing the environmental process that was followed which culminated in the approved Final Environmental Impact Statement (FETS) and the issuance of Record of Decision (ROD) by FNWA.

Mike then continued with a discussion on the causeway bridge elements to be replaced, the construction staging anticipated, and the project schedule. Construction of the first phase is estimated for 2005 and will continue in two other phases through 2008. (see slides 8 thru 23 of the attached presentation). Mike then introduced Marshall Robert of Baker to present the environmental process.

Proposed Improvements/Environmental Process:

Marshall explained that the environmental process is a continuation of the EIS mitigation from the earlier phase of this project. A question was raised regarding impact to the visitor center during construction. Marshall responded that the existing visitor will be impacted during the second phase of construction, and that the visitor center may have to be temporarily relocated into Ocean City until the new visitor center has been constructed.

There will be a website for the project to maintain communication with the public. This community partnering team will assist in developing the context sensitive design features. Community Outreach and environmental mitigation master plan will be implemented. There is also a right-ofway process for property acquisition that will be on-going and the Coast Guard has its own process for approving the 55 foot vertical clearance of the two bridge structures. (see slides 24 thru 35 of the attached presentation)

Causeway Aesthetics:

Mike Sidani introduced Fred Gottemoller to present information on the project design aesthetics. Fred explained that the project aesthetics is "what you see". The causeway replacement project is a visual asset to Ocean City, Somers Point, and the Great Egg Harbor. The proposed bridge will be more transparent than the existing structures with fewer piers. The driver's visibility will be enhanced being at twice the height, one can see the ocean.

Fred presented a sample bridge image in Clearwater Florida and then displayed a number of image(s) from Ocean City and Somers Point. The causeway aesthetics will provide a gateway to both communities.

Fred also discussed the aesthetic considerations where input will be solicited, such as Lighting, Color and Texture, Gateways and Landscaping. (see slides 36 thru 46 of the attached presentation)

Meeting Schedule:

Regarding the meeting schedule, Mike Sidani noted the need to work very actively over the next few months to resolve design issues. The final design will be presented to the public for comment in the spring at a Public Information Center meeting. There will be an additional meeting of the CPT to review the progress of each task force and to review the information to be presented at the Public Information Center. A project schedule will be provided for the CPT handbook. (see slides 47 thru 48 of the attached presentation)

Community Issues and Group Discussions:

Regarding community issues, Martine then asked members to provide issues, interests or concerns, which the team should take into consideration for the bridge replacement. The issues are listed on Attachment No. 1 of this report.

Martine then presented a number of topics for group discussion over lunch indicating that these groups may become task forces. The task forces will meet over the next few months to prioritize the issues and make recommendations to the Steering Committee for resolution and implementation. The CPT members were asked to break into seven discussion groups during lunch. The topics were: (1) Bicycle Pedestrian and Fishing Mobility, (2) Public Information/Awareness, (3) Traffic Management (4) Environmental Process and (5) Business Circulation and Access and (6) Causeway Aesthetics and the Ocean City Visitor's Center (combined due to number of people in group). Each group was asked to discuss the issues associated with the proposed replacement design and construction regarding their topic. After lunch, each group selected a presenter to share the results of their discussions, which are listed on Attachment No. 2.

To close, Martine asked members for any additional comments regarding the project, action items or feedback on today s meeting. The following feedback and closing comments were made:
