Buyer must complete and sign Certification of Buyer to include name of buyer, signature of buyer or corporate officer, title of person signing certification and date of signature.

Buyer must complete the balance of the certificate and provide all requested information.

If the certificate is not for a single sale, NO SALES MAY BE INCLUDED IF ANY DETAIL OF A PARTICULAR SALE DIFFERS FROM THE OTHER SALES AS LISTED UNDER DETAIL OF SALE.

Copies of this form and supporting documents must be retained by both the buyer and the seller for a period of three years.
