JOB DESCRIPTION

The New Jersey Cannabis Regulatory Commission, Licensing Unit is seeking a Technical Assistant 1. Under the direction of the Director of the Office of Compliance, Investigations, and Licensing or its designee, reviews licensing and programmatic documents, or other documents for accuracy, appropriateness, and completeness, identifying and resolving problem areas and processing them in accordance with rules, regulations, and laws of the assigned unit. Edits, updates, retrieves, verifies, and corrects data, exercising independent and collaborative judgment with Supervisor in making corrections to all errors. Contacts applicants/public to verify information and resolve problem situations and complaints. Prepares correspondence designed to convey information concerning the regulations and procedures as they pertain to licensing obtainment. Maintains logs of assignments and establishes a tracking system for better flow of work. Maintains essential records and files. Assists in providing statistical data and information pertaining to the work of the unit. May provide procedural information, obligations, responsibilities, and right to program participants and other interested parties.

The standard workweek is Monday through Friday. This position **may** be eligible to participate in the Department's pilot telework program, which allows eligible employees to work remotely for up to two (2) days per week, as approved by management. The position offers a comprehensive benefits package including medical, prescription drug, and dental coverage, benefit leave, Pension, supplemental pension plan, tax saving programs, and paid holidays.
