This petition involves a billing dispute between Gertrude Holmes (Ms. Holmes) and Public Service Electric and Gas Company (PSE&G). Ms. Holmes alleges PSE&G improperly billed her.

A. <u>Docket No. QO19010068 – In the Matter of a New Jersey Solar Transition Pursuant</u> to P.L. 2018, c.17 – Atlantic County Utilities Authority Motion for Reconsideration.

Atlantic County Utilities Authority (ACUA) seeks reconsideration of the Board's December 6, 2019 Order establishing the Transition Incentive Program; specifically, ACUA proposes that the 0.85 TREC factor assigned to community solar projects be changed to a 1.2 factor for community solar projects that serve exclusively Low- and Moderate-Income customers.

New Jersey School Boards Association seeks reconsideration of the Board's December 6, 2019 Order establishing the Transition Incentive Program; specifically, whether the 0.6 TREC factor assigned to net metered ground mounted projects should be raised to 1.0.

Specifically, ACUA is asking the Board to reconsider its denial of ACUA's request for a waiver of N.J.A.C. 14:8-9.10(b)(1)(i), which relates to the manner in which customers can be signed up for community solar. ACUA argues that the waiver is needed to more easily meet its goals for signing up Low- and Moderate-Income subscribers.
