### **Energy Agent and Private Aggregator Initial Registrations**

<u>EE20100666L</u> United Energy Insights, LLC EA d/b/a United Energy Consultants

This matter involves potential violations under the Electric Discount and Energy Competition Act, N.J.S.A. 48:3-49 et seq. and more specifically, N.J.S.A. 48:3-78 and N.J.S.A. 48:3-79 et seq. and N.J.A.C. 14:4-1.1 et seq. by United Energy Insights, LLC d/b/a United Energy Consultants ("UEC" or "the company"), who had been operating as an energy agent to arrange energy procurement for customers in New Jersey after the company's registration expired. UEC has submitted an Offer of Settlement ("Offer"), regarding its alleged violations. In the Offer, UEC made a monetary offer in the amount of \$3,800.00 to resolve all issues concerning the violations alleged by Staff.

### 2. ENERGY

A. Docket No. EM20070475 – In the Matter of the Petition of Atlantic City Electric Company for the Approval of the Sale of Transformers and Other Equipment Pursuant to the "RESTORE" Agreement.

The Board will consider Atlantic City Electric Company's request for approval of the potential sale of transmission equipment pursuant to the RESTORE Agreement.

**B.** Docket No. ER20110693 – In the Matter of the Petition of Atlantic City Electric Company for Approval of Electric Base Rate Adjustments Pursuant to the PowerAhead Program (11/2020).

The Board will consider Atlantic City Electric Company's PowerAhead rate roll in. The Parties have executed a stipulation which if approved, will result in an increase in the monthly bill of a typical residential customer of \$0.11.

C. Docket No. ER20110694 – In the Matter of the Petition of Atlantic City Electric Company for Approval of Electric Base Rate Adjustments Pursuant to its Infrastructure Investment Program (11/2020).

The Board will consider Atlantic City Electric Company's Infrastructure Investment Program rate roll in. The parties have executed a stipulation which, if approved, will result in an increase in the monthly bill of a typical residential customer of \$0.25.

D. Docket No. GR20070502 – In the Matter of the Petition of Elizabethtown Gas Company to Revise the Remediation Adjustment Clause Component of its Societal Benefits Charge Rate.

The Board will consider Elizabethtown Gas Company's 2020 Remediation Adjustment Clause rates. The parties have executed a stipulation, which if approved by the Board, will result in a monthly decrease of \$0.67 for a typical residential heating customer using 100 therms per month.

E. Docket No. GR20060382 – In the Matter of the Petition of South Jersey Gas Company for Approval to Revise the Rider "H" Rate Associated with the Tax Cuts and Jobs Act of 2017.

The Board will consider South Jersey Gas Company's 2020 Rider H rates. The parties have executed a stipulation for final rates, which if approved by the Board, will result in no impact to customer bills.

#### 4. TELECOMMUNICATIONS

A. Docket No. TO20050360 – In the Matter of the Petition of Verizon New Jersey, Inc. to Delete Certain Measurements and Standards from the New Jersey Carrier-to-Carrier Guidelines and the New Jersey Incentive Plan.

On May, 18, 2020, Verizon filed a petition ("Petition") with the Board seeking the removal of five billing Metrics contained in the C2C Guidelines and the IP.

#### 5. WATER

A. Docket Nos. BPU WR20110722 and OAL PUC 10953-2020S – In the Matter of the Petition of Middlesex Water Company for Approval to Change the Levels of its Purchased Water Adjustment Clause Pursuant to N.J.A.C. 14:9-7.1, et seq.

The Board will consider an Initial Decision regarding Middlesex Water Company's (MWC) Purchased Water Adjustment Clause (PWAC). The Parties have executed a Stipulation, which if adopted by the Board, will increase MWC's PWAC from \$0.6024 per thousand cubic feet of water per quarter to \$1.0280 per thousand cubic feet of water per quarter. The bill for a residential customer, with a 5/8" meter, using 17,204 cubic feet of water per quarter will increase from \$154.27 per quarter to \$155.24 per quarter, an increase of \$0.97 per quarter, which is an increase of 0.63%.

A. Docket No. QO20110727 – In the Matter of the Clean Energy Program Authorization of Commercial and Industrial Program Energy Efficiency Incentives Exceeding \$500,000 – Verizon New Jersey, Inc.

The Board will consider whether to grant Verizon an incentive of \$1,299,460.83 through the Large Energy Users Program. The incentive would help fund the installation of energy conservation measures at 30 different Verizon locations across New Jersey.

**B.** Docket No. QO21020114 – In the Matter of the Clean Energy Program Authorization of Commercial and Industrial Program Energy Efficiency Incentives Exceeding \$500,000 – West Windsor-Plainsboro High School North.

The Board will consider whether to grant the West Windsor-Plainsboro Board of Education an incentive of \$762,415.65 through the Pay For Performance – Existing Buildings Program. The incentive would help fund the installation of energy conservation measures at West Windsor-Plainsboro's High School North in Plainsboro, New Jersey.

C. Docket No. QO21020092 – In the Matter of the Clean Energy Program Authorization of Commercial and Industrial Program Energy Efficiency Incentives Exceeding \$500,000 – West Windsor-Plainsboro High School South.

The Board will consider whether to grant the West Windsor-Plainsboro Board of Education an incentive of \$799,429.91 through the Pay For Performance – Existing Buildings Program. The incentive would help fund the installation of energy conservation measures at West Windsor-Plainsboro's High School South in Princeton Junction, New Jersey.

D. Docket No. QO21020093 – In the Matter of the Clean Energy Program Authorization of Commercial and Industrial Program Energy Efficiency Incentives Exceeding \$500,000 – Merck Sharp and Dohme Corporation.
