#### BY THE BOARD1:

The New Jersey Board of Public Utilities' (the "Board") SMARTSTART Buildings Program ("SSBP" or "SMARTSTART"), Direct Install Program, and Pay-for-Performance Program offer financial incentives to New Jersey property owners to encourage the installation of energy efficient products and technologies. Eligible applicants may receive incentives for a portion of the cost of installing energy efficient technologies such as lighting, HVAC, water heating or other measures in new or existing buildings.

Meridian Hospitals Corp., Riverview Medical Center, 1 Riverview Plaza, Red Bank, NJ, has submitted an application for a monetary incentive in the amount of \$2,203,893 under the Payfor-Performance program, for a project located at 1 Riverview Plaza, Red Bank, NJ. This rebate application, Docket Number EO11040199V, will be receiving an incentive of \$49,045 for the energy reduction plan (ERP); \$1,289,162 for certain measures (including installation of variable frequency drives [VFDs] on domestic hot water booster pumps; steam trap upgrades and repairs; replacement of existing transformers with high efficiency transformers; replacement of existing lighting with energy efficient upgrades and installation of occupancy sensors; replacement of existing motors with premium efficiency motors; replacement of existing electric controls with one centralized Direct Digital Control System; installation of two new full load chillers, pump replacement, and VFDs; and replacement of old boilers with new energy-efficient gas-fired boilers); and an estimated \$865,686 for the one year true up of its ERP. This application has an estimated 21% total energy savings above the base line and will save the customer an annual estimate of 4,044,638 kWh of electricity, an annual estimate of 12,488 MMBtu of natural gas, and an estimated annual energy cost savings of \$906,835.

TRC, the Market Manager engaged by the Board to manage the New Jersey Clean Energy Program C&I energy efficiency programs, has submitted a certification dated March 3, 2011 stating that the incentives for which TRC now seeks approval to commit have been calculated in accordance with the program policies and procedures, and that the listed amounts are the true and accurate estimated incentives for which each applicant is eligible. Further, Applied Energy Group, in its role as the NJCEP Program Coordinator, has reviewed the application and submitted a certification dated April 1, 2011 stating that the incentives for which TRC now seeks approval to commit have been calculated in accordance with the program policies and procedures, and that the listed amounts are the true and accurate estimated incentives for which each applicant is eligible. Based on the above, the Staff recommends that the Board approve the above referenced application.

The Board <u>HEREBY APPROVES</u> the aforementioned application for the incentive amounts requested and <u>AUTHORIZES</u> issuance of a standard commitment letter to the applicant identified above, setting forth the terms and conditions of these commitments.
