N THE MATTER OF THE PETITION OF JJU SOLAR HOLDINGS, LLC (UNIVERSAL SUPPLY 28.08 KW) FOR AN EXTENSION OF SOLAR RENEWABLE ENERGY CERTIFICATE (SREC) PURCHASE AND SALE AGREEMENT WITH ATLANTIC CITY ELECTRIC COMPANY ("ACE")))))	ORDER DOCKET NO. QO19070838

BY THE BOARD:

In this Order, the New Jersey Board of Public Utilities ("Board") considers the petition of Infiniti Energy Services ("Infiniti" or "Petitioner") on behalf of its customer JJU Solar Holdings¹ ("JJU"). Petitioner seeks an extension of time to complete a solar energy project ("Project") under JJU's Solar Renewable Energy Certificate ("SREC") long-term financing contract with Atlantic City Electric Company ("ACE").

On or about October 15, 2018, as a winning bidder in ACE's SREC II financing program, JJU entered into an SREC Purchase and Sale Agreement ("PSA") with ACE for the SRECs from a 28.08 kw dc solar project ("Project"). The Project is to be located on the roof of a commercial property at 590 S Egg Harbor Road, Hammonton, New Jersey ("Site") and is intended to be net metered.

JJU Solar had received an SREC Registration Program ("SRP") Registration Acceptance letter with a commitment length of 12 months on June 21, 2018. On June 11, 2019, the SRP Manager granted JJU a six month completion deadline extension to December 21, 2019. The SREC Agreement executed with ACE had a construction completion deadline of April 15, 2019. On April 2, 2019, JJU requested and on April 8, 2015 received from ACE a three month extension of the SREC PSA to July 15, 2019.

In support of its request for second extension of its PSA, Infiniti avers that on December 4, 2018, it received a letter from ACE that the interconnection request for its five projects totaling 280 kwdc required a reduction to projects at approximately 50 kw dc for engineering reasons. As a result, the two remaining projects had to be redesigned to meet ACE interconnection standards for the circuit. Additionally, Infiniti, which had not realized that the SRP extension granted in June did not automatically extend the PSA with ACE, began construction on July 15, 2019. This petition was filed one week later.⁴

Petitioner states that project construction has been completed, the site passed the Authority Having Jurisdiction ("AHJ") inspections and has received a Certificate of Approval from the municipality on August 20, 2019. Infiniti states that it is finalizing as-built drawings and once completed will submit the PTO application to ACE by the end of August. JJU respectfully requests extensions to October 15, 2019 in order to submit all necessary SRP as-built and PTO documentation to the SRP Team.

By letter dated July 17, 2019, ACE states that it has reviewed the petitioner's extension request and does not oppose the additional extension to complete this project.

DISCUSSION AND FINDINGS

In addressing Petitioner's request for an extension of time to complete pursuant to its SREC financing contract with ACE, the Board looks to its previous rulings under the SREC financing program. In reviewing such requests, the Board has looked first at whether the applicant could document significant progress toward completion of the project, and, second, whether the delay was unavoidable and unforeseeable at the time of the execution of the PSA. No. QO19040444, Order dated June 12, 2019.

Applying the standard to the matter at hand, the Board notes that according to the petition, the DC portion of the installation has been completed and the AC portion is underway. In addition, the site has passed AHJ inspections and has received its Certificate of Approval from the municipality. Moreover, Petitioner states that it is finalizing the as-built drawing and that the PTO application was submitted to ACE at the end of August. The Board FINDS that Petitioner has demonstrated significant progress toward completion.

Turning to the second prong of the analysis, the Board looks at whether the cause of the delay was unavoidable and unforeseeable at the time JJU executed the PSA on October 15, 2018. The Board notes that Petitioner did not learn of the need to reduce the number and size of its

projects until almost two months after it had signed the PSA. Petitioner was also obliged to redesign the two remaining systems including the subject to this petition as a result of the engineering concerns raised by ACE. The Board <u>FINDS</u> that the delays caused by the ACE interconnection approval process were unavoidable and unforeseeable at the time Petitioner entered into its PSA with ACE. The Board therefore <u>CONCLUDES</u> that Petitioner has met the Board's criteria for granting an extension and <u>GRANTS</u> Petitioner's request for a three month extension from the expiration of the current extension to complete the Project.

The effective date of this Order is October 7, 2019.
