## INCOME ELIGIBILITY FOR USF AND LIHEAP

### HOW WE CAN HELP

There are now two important utility assistance programs available to eligible households: USF and LIHEAP. This brochure provides information about these programs and about several other energy assistance programs that may also be helpful.

#### The Low Income Home Energy Assistance Program (LIHEAP)

LIHEAP is a program that helps you pay your heating costs. Even if your heat is included in your rent, you may qualify. LIHEAP takes applications from November 1 to March 31.

You are eligible for LIHEAP if:

- ◆ Your household income is less than or equal to 175 percent of the Federal Poverty Level (see chart).

#### The Universal Service Fund (USF)

USF is a program created by the State of New Jersey to help make energy bills more affordable for low-income customers. If you are eligible, USF can lower the amount you have to pay for your gas and electric bill. USF accepts applications all year.

You are eligible for USF if:

- ◆ Your household income is less than or equal to 175 percent of the Federal Poverty Level (see chart).

#### AND

- ◆ You are paying at least 3 percent of your yearly income on electric bills or at least 3 percent of your yearly income on gas bills. If you have electric heat in your home, you must be paying more than 6 percent of your yearly income on electricity.

### HOW TO APPLY

You can apply for USF and LIHEAP with one application. You may be eligible for both programs. If you sign up between November 1 and March 31, you will be applying for LIHEAP and USF. During the rest of the year, you can only apply for USF.

### BENEFIT AMOUNTS

LIHEAP: Benefits are normally paid once a year, during the heating season. Additional benefits *may* be available at other times during the year. The amount of the benefit is based on household income and size, fuel type and region.

USF: Monthly benefits are based on household income and the amount of your annual electric and natural gas bills. The benefit will appear as a credit on your utility bill.
