

## NOTICE TO ATLANTIC CITY ELECTRIC COMPANY CUSTOMERS

In the Matter of the Petition of Atlantic City Electric Company for Approval of an Energy Efficiency Program, Cost Recovery Mechanism, and Other Related Relief for Plan Years One Through Three

Extension Petition

**BPU Docket No. EO20090621**

**PLEASE TAKE NOTICE** that, on November 17, 2023, Atlantic City Electric Company (“ACE” or “Company”) filed a letter petition (“Petition”) with the New Jersey Board of Public Utilities (“Board” or “BPU”) seeking approval to extend, by six (6) months, the energy efficiency (“EE”) programs previously approved by the Board to be implemented for a three-year period from July 1, 2021 through June 30, 2024 (“Triennium 1” or “T1”). The EE programs were proposed by ACE and approved by the Board in accordance with the Clean Energy Act of 2018. ACE is seeking approval for an incremental budget of \$29.5 million for the six-month extension. By the Petition, the Company requests a budget designed to meet customer demand for the Company’s current Triennium 1 programs.

By Order dated April 27, 2021, the Board approved the Company’s Triennium 1 programs. By Order dated May 24, 2023, the Board directed each electric and gas public utility to propose EE programs for Triennium 2 on or before October 2, 2023. By Order dated October 25, 2023, the Board found it was reasonable, prudent, and in the public interest to provide additional time for Board Staff (“Staff”) and the New Jersey Division of Rate Counsel (“Rate Counsel”) to conduct a thorough and diligent concurrent review of the Triennium 2 filings, as well as to provide parties and interested stakeholders with additional time to review, analyze, and discuss the filings. As a result, the Board ordered that Triennium 2 programs would commence on January 1, 2025, concluding on June 30, 2027, and directed the electric and gas utilities to each file a letter petition to extend their Triennium 1 programs by six (6) months to December 31, 2024 (“Extension Period”).

According to the Petition, ACE will seek recovery of the Extension Period costs in future annual rate filings through its Regional Greenhouse Gas Initiative Surcharge, known as Rider RGGI, which recovers costs associated with the Company’s Board-approved EE programs (“Programs”), and other Board-approved programs. The current Programs authorized ACE’s investment in, and implementation and administration of, a portfolio of eight (8) residential sub-programs, four (4) Commercial and Industrial sub-programs, and one (1) multifamily sub-program, including special resources for low to moderate income customers. The Programs include discounted energy saving measures, and other resources to help address barriers to saving energy and making investments in EE and Peak Demand Response improvements more accessible for all customers. Pursuant to Board Orders dated April 27, 2021 (Docket Nos. QO19010040 and EO20090621) and August 17, 2022 (BPU Docket No. ER22020114), the Company may recover all reasonable and prudent costs associated with the Programs. The approved and proposed costs included, without limitation, customer incentives and the associated incremental Operations and Maintenance expenses, along with associated carrying costs.

Because the Company will seek recovery of costs in a subsequent filing, ACE’s T1 extension request results in no immediate impact on any customer’s bill at this juncture and is strictly for approval for the BPU-ordered extension of the Triennium 1 Program.
