Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

1. By a vote of 3-0, ratified the minutes of June 12, 2013 public meeting (transcript pages 8-9).
2. By a vote of 3-0, granted the application of Vipin C. Pandya for an initial casino key employee license (Exhibit EL-1\*); and  
By a vote of 3-0, remanded the application of Aharon M. Kiett for a casino key employee license to a hearing (Exhibit EL-1\*; transcript pages 9-11).
3. By a vote of 3-0, granted the resubmitted applications of Christine A. Boxer, William R. Cestone, Gerald M. Core, Robert H. Deissler, John D. Durney Jr., Davida S. Fisher, Ronald A. Rossetti (Ruling numbers 13-07-10-07-A; 13-07-10-07-B ; 13-07-10-07-C ; 13-07-10-07-D, 13-07-10-07-E, 13-07-10-07-G; 13-07-10-07-H ; 13-07-10-07-I, 13-07-10-07-J, 13-07-10-07-K; transcript pages 18-20).

8. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Thomas C. Fiore; and granted the resubmitted application of Mr. Fiore, for a casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 13-0009-CR) (Ruling number 13-07-10-08; transcript pages 20-22).

9. By a vote of 3-0, approved the stipulation of settlement between the Division of Gaming Enforcement and Teresa C. Moody-Butler; and granted the application of Ms. Butler, for an initial casino key employee license, subject to compliance with certain financial and reporting conditions, as provided for in the stipulation (DKT 13-0002-CK) (Ruling number 13-07-10-09; transcript pages 22-25).

10. Considered the petition of Caesars Entertainment Corp. and Caesars Entertainment Operating Company, Inc. and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and found Donald A. Colvin, qualified to serve as Executive Vice President and Chief Financial Officer of Caesars Entertainment Corp. and Caesars Entertainment Operating Company, Inc., in accordance with N.J.S.A. 5:12-85.1c, N.J.S.A. 5:12-89b(1), N.J.S.A. 5:12-89b(2) and N.J.A.C. 13:69C-2.7 (Ruling number 13-07-10-10; transcript pages 25-27).

11. Considered the amended and restated stipulation regarding the qualification of Steven L. Scheinthal, Vice President and Secretary of Golden Nugget Atlantic City, LLC, Golden Nugget, LLC and Fertitta Entertainment Holdings, LLC and issued the following ruling:

By a vote of 3-0, approved the amended and restated stipulation of settlement between the Division of Gaming Enforcement and Steven L. Scheinthal; and found that Mr. Scheinthal continued to meet the requirements for key license and qualification, subject to compliance with the conditions contained in the stipulation of settlement (Ruling number 13-07-10-10; transcript pages 30-32).

12. Considered the petition of Caesars Entertainment Corporation and Caesars Entertainment Operating Company, Inc. and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and authorized Thomas Arasi, on a temporary basis and prior to his plenary qualification, to assume the duties and exercise the powers a Member of the CEC Capital Committee for Caesars Entertainment Corporation and Caesars Entertainment Operating Company, Inc., pending plenary qualification, subject to the conditions contained in N.J.S.A. 5:12-85.1 c; N.J.S.A. 5:12-89 b (1) and N.J.S.A. 5:12-89 b (2); and N.J.A.C. 13:69C-2.7 (Ruling number 13-07-10-12; transcript pages 27-30).

13. Considered the petition of Revel Entertainment Group ,LLC and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and authorized Loretta Pickus, on a temporary basis and prior to her plenary qualification, to assume the duties and exercise the powers as Senior Vice President Legal-General Counsel for Revel Entertainment Group, LLC and Revel, AC, Inc., pending plenary qualification, pursuant to N.J.A.C. 13:69C-2.6(a) and N.J.A.C. 13:69C-2.7(c) and N.J.A.C. 13:69C-2.7(d) (PRN 1861301) (Ruling number 13-07-10-13; transcript pages 33-36).

14. Considered the amended petition of Revel Entertainment Group ,LLC and issued the following ruling:

By a vote of 3-0, adopted the draft resolution and authorized Scott Kreeger, on a temporary basis and prior to his plenary qualification, to assume the duties and exercise the powers as Interim Chief Operating Officer of Revel Entertainment Group, LLC and Revel, AC, Inc., pending plenary qualification, pursuant to N.J.A.C. 13:69C-2.6(a) and N.J.A.C. 13:69C-2.7(c) and N.J.A.C. 13:69C-2.7(d) (PRN 1841302) (Ruling number 13-07-10-13; transcript pages 36-39).


There being no members of the public to address the Commission, the meeting adjourned at 10:53 a.m.
