CONCERNING THE PETITION OF REVEL ENTERTAINMENT GROUP, LLC AND
REVEL AC, INC. FOR APPROVAL OF A PREPACKAGED PLAN OF
BANKRUPTCY AND RELATED RULINGS
(PRN 1211301)

WHEREAS, Revel Entertainment Group, LLC (Revel), a New Jersey limited liability company, holds a casino license issued by the New Jersey Casino Control Commission (Commission) on March 26, 2012 (Resolution No. 12-03-26-05); and

WHEREAS, Revel is a wholly-owned subsidiary of qualified holding company Revel AC, LLC, a Delaware limited liability company wholly-owned by qualified holding company Revel AC, Inc. (Revel AC), a Delaware corporation which is wholly-owned by qualified holding company Revel Group, LLC, a Delaware limited liability company; and

WHEREAS, on February 17, 2011, Revel AC entered into a first lien credit agreement (Term Loan Credit Agreement) consisting of an \$850 million secured term loan (Term Loan Credit Facility); and issued \$304.4 million in 12% second lien notes due 2018 (Second Lien Notes); and issued 152,200 units, each consisting of a warrant to purchase 1,000 shares of common stock of Revel AC, (Warrants) and \$2,000 principal amount of Second Lien Notes; and



WHEREAS, on May 3, 2012, Revel AC entered into amendments to the Term Loan Credit Facility providing for, *inter alia*, an additional \$50 million of term loan commitments; and

WHEREAS, on May 3, 2012, Revel AC entered into a revolving credit facility (the Revolver), as amended on August 21, 2012, for up to \$100 million, as amended in December 2012 to \$125 million; and in December 2012 entered into a \$125 million term loan (collectively, the 2012 Credit Agreement); and

WHEREAS, on March 25, 2013, Revel, its qualified holding companies Revel AC and Revel AC, LLC and entity qualifiers Revel Atlantic City, LLC, and NB Acquisition, LLC (collectively, the Debtors) filed a voluntary petition for relief under Chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the District of New Jersey (Case No.13-16253 (JHW)) and a proposed Joint Plan of Reorganization dated March 13, 2013, as supplemented, (the Plan, P-1 through P-3, in evidence) and Disclosure Statement; and

WHEREAS, on March 27, 2013, the Debtors received approval from the Bankruptcy Court for, and entered into, a \$250 million senior secured debtor in possession credit agreement (DIP Credit Agreement), consisting of a \$125 million term loan and a \$125 million revolving line of credit; and

WHEREAS, pursuant to the Plan, Revel AC will enter into Exit Facilities consisting of a revolving credit facility (the First Lien Exit Facility) in the amount

of \$75 million (Exit Revolver), and a Term Loan in the aggregate amount of approximately \$275 million (the Second Lien Exit Facility); and

WHEREAS, the Plan provides that (a) loans outstanding under the 2012 Credit Agreement will be paid in full in cash on a pro rata basis; and (b) loans outstanding under the Term Loan Credit Agreement will be fully satisfied by conversion into 100% of New Common Equity Interests in Revel AC; and (b) holders of the Second Lien Notes will receive a pro rata share of Contingent Payment Rights under the State Economic Redevelopment and Growth Incentive Grant Agreement dated February 11, 2011; and (c) all equity interests in Revel AC, including all Warrants, will be extinguished; and (d) claims of general unsecured creditors will be unimpaired; and

WHEREAS, on May 13, 2013, the Bankruptcy Court issued an opinion confirming the Plan under Chapter 11 of the United States Bankruptcy Code; and

WHEREAS, on May 7, 2013 and May 13, 2013, Revel filed PRNs 1271301 and 1331302 seeking permission for Gregory Roselli, Thomas Michael Benninger, Jeffrey Jay Dahl and Peter Murphy each to perform the duties and exercise the powers of a member of the Revel AC Board of Directors pending plenary qualification and for a nine-month period in accordance with the conditions contained in *N.J.A.C. 13:69C-2.7*; and

WHEREAS, on May 7, 2013, Revel filed PRN 1271302 requesting that the Division of Gaming Enforcement (Division) grant a waiver of qualification pursuant to *N.J.S.A. 5:12-85.1g* for each of the following holders of 5% or more of the issued and outstanding equity interests in Revel AC: Capital Research; Canyon Capital; Oppenheimer Funds; and Credit Suisse; and

WHEREAS, On April 29, 2013, Chatham Revel VoteCo, LLC filed PRN 1191304 requesting that the Commission grant interim casino authorization pursuant to *N.J.S.A. 5:12-95.12 et seq.* as the holder of equity interests in Revel AC; and

WHEREAS, by PRN 1211301 filed on May 1, 2013, Revel seeks Commission approval of the Plan and related rulings (the Petition); and

WHEREAS, the Division filed a report dated May 10, 2013, regarding the Petition; and

WHEREAS, the Commission considered the Petition at its public meeting on May 15, 2013;

NOW, THEREFORE, BE IT RESOLVED by the Commission, that the relief requested in the Petition is hereby APPROVED, based upon and to the extent set forth in the findings and rulings, and subject to the conditions, contained in this resolution, as follows:



FINDINGS and RULINGS

Based upon consideration of the entire record of these proceedings, the Commission issues the following declaratory rulings and makes the following findings:

1. The casino licensee and its holding companies and intermediary companies will, upon consummation of the Reorganization Plan, continue to possess the financial stability, integrity and responsibility required by the Act.

2. The transfer of equity and issuance of the New Common Equity Interests are APPROVED pursuant to *N.J.A.S. 5:12-105a* and *N.J.A.C. 13:69C-2.8*, subject to a finding by the Division Director that holders of the New Equity are qualified or waived from qualification pursuant to *N.J.S.A. 5:12-85.1*; and

3. The consummation of the Reorganization Plan is APPROVED.

CONDITIONS

1. Executed copies of all documents relating to the findings and rulings herein shall be filed with the Division within 10 days of the effective date of the Plan;

2. Revel shall immediately notify the Division, in writing, of any material changes to the Plan as described in PRN 1211301;



3. Within 10 days of the effective date of the Plan, Revel shall submit to the Division a financial covenant compliance forecast on a quarterly basis through 2015;

4. Within 5 days of the approval of the Revel, Inc. Board of Directors, Revel shall submit to the Division (a) any updated forecasts; and (b) a financial covenant compliance analysis that reflects such updated forecasts;

5. Financial information submitted by Revel to the Exit Facility Lenders, including but not limited to compliance certificates, shall be simultaneously provided to the Division;

6. Revel shall immediately notify the Division of any borrowings or repayments on the Exit Revolver, including a schedule in the format approved by the Division, which shall update the amount of the Exit Revolver commitment utilized, the gross remaining Exit Revolver availability and the remaining Exit Revolver availability under the minimum liquidity covenant;

7. By the 30th day of each month, Revel shall provide an updated Sources and Uses of Cash, in a format approved by the Division, which shall include (a) actual results for the prior month; (b) updated projections for, at a minimum, the next 13 weeks; (c) a summary of the Exit Revolver availability; and (d) a detailed explanation of any material variance from the prior month's forecast and any planned corrective actions. If the Exit Revolver availability



falls below \$25 million, the updated Sources and Uses report must be submitted on a weekly basis;

8. In the event that Revel projects that its available funds will be insufficient to address its projected cash needs for at least the next 13 weeks as contained in the updated Sources and Uses of Cash report in Condition 7 above, Revel shall immediately advise the Division and shall provide a detailed plan to address the potential shortfall;

9. By the 30th day of each month, Revel shall provide to the Division an update regarding the status of litigation or related developments associated with the initial construction of the Revel casino hotel;

10. By the 30th day of each month, Revel shall provide to the Division an accounts payable aging schedule as of the previous month-end that reconciles to the month-end balance sheet; and

11. Any request to modify or eliminate any condition contained herein shall require the approval of the Division Director or his designee, with notice of any such revision to the Commission.
