5. At least 15 days prior to the due date under the regulations, CEC shall submit to the Division a draft of the first quarterly financial report due from the Successor Licensees after the Effective Date, along with a detailed summary of the changes stemming from the Transactions;
6. CEC and CEOC LLC shall provide the Division and the Commission with any documentation regarding a proposed allocation of CEOC LLC's lease payments to VICI Properties Inc. on the financial statements of the Successor Licensees, and shall obtain Division approval prior to implementation of any such allocation;
7. No later than 30 calendar days after the Effective Date of the Plan, CEC shall provide documentation to the Division demonstrating that all of the following Intercompany Notes have been canceled:
