



RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION CONCERNING THE PETITION OF GOLDEN NUGGET ATLANTIC CITY LLC D/B/A GOLDEN NUGGET HOTEL AND CASINO FOR QUALIFICATION OF NEW HOLDING COMPANIES AND NATURAL PERSON QUALIFIERS OF GOLDEN NUGGET ATLANTIC CITY LLC AND OTHER RELIEF PURSUANT TO N.J.S.A. 5:12-1 ET.SEQ. (PRN 2911701)

WHEREAS, Golden Nugget Atlantic City LLC d/b/a Golden Nugget Hotel and Casino (GNAC) filed a Petition on October 18, 2017 seeking a ruling from the Casino Control Commission (Commission) pursuant to N.J.S.A. 5:12-1 et.seq. (the Act) finding the newly identified holding companies of GNAC qualified as a result of a realignment and refinancing transaction (Reorganization) and finding that the natural person qualifiers of the newly identified holding companies remain qualified; and

WHEREAS, on February 15, 2012 pursuant to Resolution No. 12-02-15-14 the Commission granted plenary casino licensure to GNAC and found Golden Nugget LLC (Golden Nugget) and Fertitta Entertainment Holdings, LLC (Fertitta Entertainment) qualified as holding companies of GNAC; Fertitta Entertainment, Inc. (FEI), Fertitta Group, Inc., Landry's Holdings, Inc, and Landry's Inc. f/k/a Landry's Restaurants, Inc. (Landry's) qualified as entities required to qualify pursuant to N.J.S.A. 5:12-85.1 for purposes of GNAC's casino licensure; and Tilman J. Fertitta, Steven L. Scheinthal and Richard H. Liem, among others, qualified as natural person qualifiers of GNAC; and



WHEREAS, on October 13, 2017, pursuant to *N.J.S.A. 5:12-87.1*, the Division of Gaming Enforcement (Division) reviewed the casino license of GNAC and its holding companies, entity qualifiers and natural person qualifiers, including, among others, FEI, Golden Nugget, Tilman J. Fertitta, Steven L. Scheinthal and Richard H. Liem and determined that GNAC, its holding companies, entity qualifiers and natural person qualifiers continued to meet the requirements for licensure as set forth in *N.J.S.A. 5:12-84* and *-85*; and

WHEREAS, on September 25, 2017, GNAC filed PRN 2691701 seeking an Order from the Director of the Division (Director) designating the required holding companies of GNAC and the associated natural person qualifiers required to qualify under the Act in connection with the Reorganization; and

WHEREAS, in conjunction with the Reorganization, Golden Nugget, Inc. (GNI) undertook certain material debt transactions for which approval was sought from the Division by PRN 2831701 filed on October 9, 2017 and amended on October 10, 2017; and

WHEREAS, on October 19, 2017 the Director entered Order PRN 2691701 designating GNI, Landry's Gaming, Inc. (Landry's Gaming), Landry's Fertitta, Inc. (Landry's Fertitta), Golden Landry's Inc. (Golden Landry's), Golden Feritta, Inc. (Golden Fertitta) and FEI as new holding companies of GNAC upon completion of the Reorganization; Tilman J. Fertitta, Steven L. Scheinthal and Richard H. Liem as natural person qualifiers of GNAC on the basis of positions held with GNAC, Golden Nugget, FEI and Landry's as well as for positions to be



held with the newly designated holding companies GNI, Landry's Gaming, Landry's Fertitta, Golden Landry's and Golden Fertitta; and

WHEREAS, by Order PRN 2831701 entered October 20, 2017, the Division approved the material debt transaction and determined that GNAC would remain financially stable following completion of the Reorganization in accordance with the Act and that GNI demonstrated its financial stability and further required, *inter alia*, that GNI and its related new entities be found qualified by the Commission as holding companies of GNAC before GNAC becomes a subsidiary of GNI; and

WHEREAS, by report filed October 25, 2017, the Division recommended that the Commission grant the relief requested; and

WHEREAS, the Commission considered the entire record in this matter, together with the presentations of counsel, at its public meeting of November 1, 2017.

NOW, THEREFORE, BE IT RESOLVED, by the Commission that based upon the report of the Division and all other evidence presented to the Commission at the public meeting of November 1, 2017, Petitioner's request to qualify GNI, Landry's Gaming, Landry's Fertitta, Golden Landry's, Golden Fertitta and FEI is hereby GRANTED based upon the findings and rulings specified herein.



FINDINGS and RULINGS

Based upon consideration of the entire record of these proceedings, the Commission enters the following findings and rulings:

1. GNI, Landry's Gaming, Landry's Fertitta, Golden Landry's, GoldenFertitta and FEI and its natural person qualifiers hereto have complied with all requirements regarding the submission of information necessary to the Commission and the Division to evaluate PRN 2911701;
2. The persons whose qualification needs to be established for purposes of PRN 2911701 are Tilman J. Fertitta, Steven L. Scheinthal and Richard H. Liem, each of whom has previously been found qualified by the Commission and remain qualified pursuant to the applicable provisions of the Act;
3. GNI, Landry's Gaming, Landry's Fertitta, Golden Landry's, Golden Fertitta and FEI have each established compliance with *N.J.S.A. 5:12-82d(7),(8) and (10) and 85b*;
4. GNI, Landry's Gaming, Landry's Fertitta, Golden Landry's, Golden Fertitta and FEI have each established by clear and convincing evidence that it possesses the financial stability, integrity and responsibility and good character, honesty and integrity required by *N.J.S.A. 5:12-84 and 85.1*; and




5. GNI, Landry's Gaming, Landry's Fertitta, Golden Landry's, Golden Fertitta and FEI, in view of the foregoing and the entire record of the proceeding, are each qualified pursuant to N.J.S.A. 5:12-85.1.
