FINAL ADMINISTRATIVE ACTION OF THE CIVIL SERVICE COMMISSION

In the Matter of Maniben Patel, Senior Library Assistant (PM1284S), Jersey City

Examination Appeal

Maniben Patel appeals the attached determination of the Division of Selection Services (Selection Services) that she filed a late application for the promotional examination for Senior Library Assistant (PM1284S), Jersey City.

The subject examination was announced with a closing date of September 22, 2014 and an application deadline of September 29, 2014. The promotional announcement, which was posted on September 8, 2014, instructed applicants that only online applications would be accepted. The resulting eligible list containing the names of three eligibles was promulgated on January 22, 2015 and expires on January 21, 2018. A certification was issued on January 28, 2015; however, no appointments have yet been made.

On October 3, 2014, the appellant filed her application for the subject examination. The appellant also notified Selection Services that several deaths and other family matters had caused her to be absent from work on September 8, 22 and 24, 2014; and to only be at work for a half day on September 15 and 23, 2014 and from September 25, 2014 through October 3, 2014. The appellant also submitted notices of the related funerals. In response, Selection Services returned the appellant's application and her application fee, indicating that her late application would not be accepted.

On appeal to the Civil Service Commission (Commission), the appellant contends that she was unable to timely submit her application because she had to take care of her sick mother and due to the deaths of several individuals which caused her to miss work. Specifically, the appellant states that her cousin's mother passed away on September 13, 2014; her neighbor's grandson passed away on

September 21, 2014; and her uncle passed away on September 27, 2014. The appellant claims that she assisted with funeral arrangements and "had to field many phone calls seeking support because [she] is a committee woman and community activist in the Indian community."

It is noted that agency records reveal that the appellant was appointed to the subject position provisionally pending promotional examination procedures, effective June 30, 2014.

CONCLUSION

N.J.A.C. 4A:4-2.6(a)4 provides that applicants must file an application on or before the application deadline. N.J.A.C. 4A:4-6.3(b) provides that the appellant has the burden of proof in examination appeals.

In the instant matter, the appellant contends that taking care of her sick mother and mourning the deaths of family members and a friend caused her to file her application late. However, although the Commission is sympathetic to the appellant's circumstances, according to her own account she was present in the workplace for at least eight days and several more half days prior to the application filing date. See In the Matter of Sandra Diaz (MSB, decided May 10, 2006) (Appellant's claim that she had to take care of her four children who had various health conditions not a sufficient basis to accept her late application). Moreover, there is no basis to relax N.J.A.C. 4A:4-2.6(a)4 since the examination resulted in a complete list of three eligibles. Accordingly, the appellant has failed to meet her burden of proof in this matter.

ORDER

Therefore, it is ordered that this appeal be denied.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.



Your appeal must include specific details that explain why you should be eligible and all proofs, arguments, and issues which you plan to use to substantiate your appeal. We regret that we cannot accept telephone, in-person or late appeals. ONLY TIMELY WRITTEN APPEALS WILL BE ACCEPTED. Please be advised that pursuant to Public Law 2010, c26, effective July 1, 2010, there shall be a \$20 fee for appeals. Please include the required \$20 fee with your appeal. Payment must be made by check or money order only, payable to NJCSC. Persons receiving public assistance pursuant to Public Law 1947, c.156 (C.44:8-107 et seq.), P.L. 1973, c256 (C.44:7-85 et seq.), or Public Law 1997, c38 (C.44:10-55 et seq.) and individuals with established veterans preference as defined by N.J.S.A. 11A:5-1 et seq. are exempt from this appeal fee, and those qualifying for New Jersey Civil Service Veterans Preference are exempt from this appeal fee.
