The Division of State and Local Operations in conjunction with the Department of Education, requests consolidation of the following eight variant titles in the Planning Associate series into one new variant title series, which will be called Planning Associate - School/Education Programs.

This consolidation will provide the Department of Education with the flexibility needed to more effectively meet its’ responsibilities. Upon successful completion of the consolidation process, the eight variant titles involved will be inactivated.

The definition, requirements, and knowledge, skills and abilities of the eight variant titles have been combined to create the title specification of the ‘new’ variant title. The Department of Education has been given the opportunity to review the proposed specification and all articulated concerns have been discussed and resolved. The eight variant titles are all currently allocated to the Non-Competitive division of the career service, thus we request that the new and consolidated titles be likewise established as Non-Competitive.

The title series will be numbered in accordance with the current practice, with the numerical suffix “1” representing the lowest level (entry level) to “3” representing the highest level in this series.
