## 2nd Annual State Workforce Diversity Summit to be Held Virtually by The New Jersey Civil Service Commission

**TRENTON** - The New Jersey Civil Service Commission (CSC) will host its Second Annual Diversity and Inclusion Summit, virtually - **Thursday, December 3, 2020 from 9:30 am to 12:00 pm**. This year's Summit is entitled, "2020 Vision: Managing Change, Conflict, and Creating Opportunities."

This year's event will feature a presentation by Cedric Ashley, Esq. on *The Intersectionality of Emotional Intelligence and Diversity, Equity, and Inclusion*; and a panel on *Best Practices in Diversity and Model Programs*; followed by an open forum/Q&A. Other panelists participating in the Summit include representatives from the New Jersey Office of Homeland Security and Preparedness, the Office of the Attorney General, the Department of Education, the Cumberland County Prosecutor's Office, and the NJ Department of Labor and Workforce Development.

"We are proud to host our Second Annual Diversity Summit in a virtual format as we continue to work toward creating a diverse pool of talented and qualified individuals that reflects the population of our state," said Deirdré L.
