REQUEST FOR TESTIMONY

The New Jersey Clean Water Council seeks public testimony on successful and unsuccessful public and private efforts to design, permit, finance, construct and maintain cutting edge "green technology" and "green infrastructure" projects, using both engineered and natural technologies for water supply, wastewater and stormwater management. Specifically, the Council seeks input and reaction to the following questions:

- **What innovative and economically viable technologies should be employed to manage water resources, including stormwater?**
- **What can be done to link traditional gray infrastructure and "green" technology or infrastructure to manage and protect water resources?**
- **What can be done to hasten testing & deployment of developing technologies that show promise?**
- **What regulations and programs must be revised in order to eliminate obstacles or barriers?**
- **How can the use of these technologies be encouraged to municipalities and the public?**
- **How can the NJ Environmental Infrastructure Financing Program be more supportive of innovative technology projects?**
- **What other funding sources are available; how can funding from multiple sources be pooled?**
