Dear Mr. Sheehan:

The New Jersey Department of Environmental Protection's (Department) Division of Sustainable Waste Management is in receipt of a proposed amendment to the Burlington County District Solid Waste Management Plan (County Plan) dated August 21, 2023. This amendment to the County Plan proposes County Plan inclusion of corrections to inconsistencies and typographical errors to the updated 2021 Burlington County District Solid Waste Management Plan, which was certified by the Department on September 6, 2022. These include the following revisions:

- Section V.D. Sanitary Landfill Closure Escrow- The citation in the second paragraph shall be corrected to *N.J.A.C. 7:26-2A.9(c)9*.
- Section VI.1.b.(4)(a)i - Landfill Capacity-In the first sentence of the third paragraph strike 2,5158,737 cubic yards and replace it with 2,158,737 cubic yards.
- Section VI.A.2.a - the name Republic Waste Services, Inc. shall be revised to *Republic Servies of NJ, LLC*.
- Section VI.A.2.b - Hainesport Industrial Railroad, LLC ("HIRR") – the words "and intermodal container facility" shall be stricken.
- Section VI.A.3 – Intermodal Container Facilities – Item a. Hainesport Industrial Railroad, LLC shall be stricken.

Pursuant to N.J.A.C. 7:26.11(b)14, the inclusion of revisions to the 2021 Burlington County District Solid Waste Management Plan can be accomplished via administrative action. Therefore, the revisions to the 2021 Burlington County District Solid Waste Management Plan is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
