The New Jersey Department of Environmental Protection, Division of Solid and Hazardous Waste is in receipt of a proposed amendment to the Middlesex County District Solid Waste Management Plan (County Plan) dated October 25, 2022. Administrative Action 005-22 to the County Plan proposes County Plan inclusion of the deletion of the following eleven (11) facilities from the County Plan which were either included in the plan for more than two (2) years but for which a complete permit application has not been made, or which were included in the plan but has not been in operation for more than two (2) years:

- Quarry Lane Compost Class B & C Recycling Center, located at Block 224, Portion of Lot 13 at 345 Quarry Lane in the Township of North Brunswick;
- GP Harmon Recycling Class A Recycling Center, located at Block 376, Lot 20 at 300 Mill Road in the Township of Edison;
- Clayton Block Class B Recycling Center, located at Block 198-L, Lot 39 at 1025 Route 1 South in the Township of Edison;
- Reclamation Technologies, Inc. Class B Recycling Center, located at Block 5001, Lots 7.11, 7.13, 10, and 17 at 3200 Bordentown Avenue in the Township of Old Bridge;
- Woodbridge Township Class A & C Recycling Center, located at Block 41C, Lot 3A at 225 Smith Street in the Township of Woodbridge;
- Republic Services – Midco Woodbridge Facility TS/MRF, located at Block 57, Lots 1.021, 2, and 3 at 440 Smith Street in the Township of Woodbridge;
- E.R. Squibb and Sons Medical Waste Facility, located at Block 194, Lot 18 at 1 Squibb Place, P.O. Box A1 in the City of New Brunswick;

- Raritan Bay Medical Center Medical Waste Facility, located at Blocks 2-20, Lot 199 at 530 New Brunswick Avenue in the City of Perth Amboy;
- Robert Wood Johnson University Hospital Medical Waste Facility, located at Block 26, Lots 9, 9.01, 10, 11, and 12 at 1 RWJ Place in the City of New Brunswick;
- Smithkline Beecham Medical Waste Facility, located at Block 457.2, Lot 6.01 at 101 Possumtown Road in the Township of Piscataway; and,
- St. Peter's Medical Center Medical Waste Facility, located at Block 449, Lot 1 at 254 Easton Avenue in the City of New Brunswick.

Pursuant to N.J.A.C. 7:26-6.11(b)7, the deletion of any facility included in the plan for more than two (2) years but for which a complete permit application has not been made, or which were included in the plan but has not been in operation for more than two (2) years can be accomplished via an administrative action. Therefore, the County Plan deletion of the above identified facilities is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
