The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a request for administrative action to the Middlesex County District Solid Waste Management Plan (County Plan) dated November 17, 2016. Administrative Action 005-16 to the County Plan proposes County plan inclusion of minor changes to the County Plan consisting of:

- Amending the procedure for obtaining County approval for County Plan inclusion of a Class C vegetative and leaf composting operation [identified in N.J.A.C. 7:26A-1.4(a)13] to follow the Administrative Action procedure for Class A facilities currently contained in the County Plan.
- A deletion of the section of the County Plan that had required municipalities to update their ordinances to include specific requirements about notification and reporting of the disposal and recycling of construction and demolition waste.
- Modifications to the Application Filing Requirements for Recycling and Solid Waste Facilities.
- The deletion of the following fourteen (14) facilities from the County Plan that have not been in operation for more than two (2) years:
 - American Waste Technologies TS/MRF, located on Block 5001, Lots 7.11, 7.13, 10 & 17 at 3200 Bordentown Avenue in the Township of Old Bridge;
 - All Container Class A Recycling Center, located on Block 164, Lot 17 at 28 Howard Street in the Township of Piscataway;
 - o Carfa Class A Recycling Center, located on Block 300, Lot 1.01 at 2201 Roosevelt Avenue in the Borough of South Plainfield;
 - Dauman Class A & B Recycling Center, located on Block 11.01, Lots 20, 23.01, 31.01, 40-43, 50, 52, 58 & 60 at 35-37 Salt Meadow Road in the Borough of Carteret;

- o Hesstech Class D Recycling Center, located on Block 375-EE, Lot 27A at 45 Executive Drive in the Township of Edison;
- o JNC Materials Class B Recycling Center, located on Block 5.02, Lot 1.02 at 340 Roosevelt Avenue in the Borough of Carteret;
- o NL Industries Landfill, located on Block 257, Lot 1 at the foot of Chevalier Avenue in the Borough of Sayreville;
- o Plainsboro Compost Class C Recycling Center, located at Block 11, Lot 27.01 at Grovers Mill Road in the Township of Plainsboro;
- o Reliable Computer Class A Recycling Center, located at Block 18, Lot 9.011 at 174 Ridge Road in the Township of South Brunswick;
- Sims Recycling Solutions Class D Recycling Center, located at Block 398, Lot 26.02 at 401 Mill Road in the Township of Edison;
- South Plainfield Compost Class C Recycling Center, located at Block 386, Lot
 1.01 at Kenneth Avenue in the Borough of South Plainfield;
- South River Compost Class C Recycling Center, located at Block 390, Lot 1 at Whitehead Avenue in the Borough of South River;
- o Turnpike Recycling Class A Recycling Center, located at Block 1, Lot 2.4 at 1000 Port Carteret Avenue in the Borough of Carteret; and,
- Woodbridge Sanitary Pottery Landfill, located at Block 410A, Lot 100 at Green Street in the Township of Woodbridge.

Pursuant to N.J.A.C. 7:26-6.11(b)14, the inclusion of minor changes to the County Plan can be accomplished via an administrative action and pursuant to N.J.A.C. 7:26-6.11(b)7, the deletion of any facility which is included in the plan but has not been in operation for more than two years can be accomplished via an administrative action. Therefore, the minor changes to the County Plan and the County Plan deletion of the above identified facilities is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
