### Section 1 (Downloading the Form):

Save a local copy of the PDF file "2022 CPCN Annual Collector Transporter Utility Report.pdf".

In order to use all of the features the file will need to be opened in Adobe Acrobat Reader with a version of Adobe Reader XI or higher. It is a free software available for download at <a href="https://get.adobe.com/reader/">https://get.adobe.com/reader/</a>.

### Section 2 (New Features):


