

Sewage Sludge Production by Management Mode - 2009

The following tables present data on sewage sludge removal for the calendar year 2009 in the State of New Jersey. This information is compiled from reports submitted by sewage sludge generators.

Summary: The first table presents the quantities of sewage sludge generated and modes of management in the state of New Jersey in the year 2009. The information is presented by county; subtotaled by county and mode; and totaled for the state. The percentage managed in each mode is also presented.

Detail: This table presents the detailed amount of sewage sludge reported removed by mode by individual generators in the year 2009. The information is presented by county and then by municipality and then by generator permit number. The information is subtotaled by mode by county.

Notes:

1. All sewage sludge values are presented in Dry Metric Tons/Year.
2. Management mode column headings are defined, as follows:

INCINERATOR CUSTOMER: Generator's sewage sludge is managed at a New Jersey sewage sludge incinerator owned and operated by another entity.

INCINERATOR OWNER: Generator incinerates sewage sludge in its own, permitted, on-site facility.

CLASS A BENEFICIAL USE: Generator's sewage sludge is processed in New Jersey by a system designed to prepare Exceptional Quality sewage sludge for beneficial use as a fertilizer or other soil amendment. The process must meet specific pathogen reduction, vector attraction reduction and pollutant standards.

CLASS B BENEFICIAL USE: Generator's sewage sludge is processed in New Jersey by a system designed to prepare Non-Exceptional Quality sewage sludge for beneficial use as a fertilizer or other soil amendment. The process must meet specific but lesser pathogen reduction, vector attraction reduction and pollutant standards which, when combined with site restrictions and management practices, are equally protective of human health and the environment.

OUT-OF-STATE BENEFICIAL USE: Generator's sewage sludge is managed in a beneficial use system located in another state. Generator is required to demonstrate compliance with regulations applicable in the receiving jurisdiction.

OUT-OF-STATE DISPOSAL: Generator's sewage sludge is managed in another state. Generator is required to demonstrate compliance with regulations applicable in the receiving jurisdiction.

IN-STATE BENEFICIAL USE LANDFILL COVER: Generator's sewage sludge is beneficially used by a New Jersey landfill specifically permitted by the Department to utilize the material as a landfill cover component.

REED BEDS/OTHER: Generator operates a system that warrants infrequent (less than once/year) removal of sewage sludge. The most common is the Phragmites Reed Bed system.
