NJDEP TRANSPORTER REQUIREMENTS

IF A COMPANY CHOOSES TO UTILIZE LQG CONSOLIDATION SITES – THERE ARE TWO OPTIONS

- 1. CONTRACT WITH AN A-901 LICENSED TRANSPORTER (DEP PREFERRED METHOD); OR
- 2. THE COMPANY CAN TRANSPORT THEIR OWN HAZARDOUS WASTE FROM A VSQG LOCATION TO A DESIGNATED LQG CONSOLIDATION LOCATION

NJDEP TRANSPORTER REQUIREMENTS

IF A COMPANY ELECTS TO TRANSPORT THEIR OWN HAZARDOUS WASTE

- THEY MUST OBTAIN A SELF-GENERATOR REGISTRATION FROM NJDEP
 - SIMPLE APPLICATION PROCESS
 - PROVIDE GENERAL COMPANY & CONTACT INFO
 - MOTOR VEHICLE REGISTRATION
 - INSURANCE COVERAGE
 - COMPLETE AFFIDAVIT THAT WASTE IS SELF-GENERATED
 - RECEIVE HAZARDOUS WASTE DECALS TO TRANSPORT SELF-GENERATED WASTE
