


Bus Reservation Information and Application

BUS RESERVATION APPLICATION

It is recommended that bus reservation requests be made at least ten (10) days in advance, but not less than five (5) days. At the time of arrival, you MUST present, your confirmed application, two (2) completed copies of our manifest and final payment. **The bus and driver of each bus must remain in the park during your visit, NO Exceptions.** Reservation is not confirmed until you receive a signed confirmation from our office.

Fees are \$65.00 for NJ-state bus group(s) and \$120.00 for out-of-state bus group(s). Bus reservation fees are determined by group's address. Each Vehicle/Car (with group) will pay Parking Fee Upon Arrival. The Parking Fee is determined by the License Plate on the Vehicle/Car NJ Res \$ 6.00 per/car or Non-Res \$ 10.00 per/car. All applicants need to submit a \$25.00 Reservation Fee Per Bus at the time of registration to hold the bus reservation. The reservation fee will be applied to final payment and is Non-Refundable if the reservation is cancelled. Rescheduling is permitted, permitting Availability, please call in advance.

Bus reservations may not be accepted after August 15th
