WHEREAS the Real Estate Commission has secured evidence which indicates that Respondent Magliaro has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and Respondent Magliaro have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS Magliaro admits that she acted in violation of N.J.A.C. 11:5-6.4(b) by failing to make a reasonable effort to ascertain all material information concerning the physical condition of a property for which she accepted an agency by failing to conduct a visual inspection of the property; and

WHEREAS Magliaro admits that she acted in violation of <u>N.J.A.C.</u> 11:5-6.2(a)(5) by failing to obtain initials of all parties to a change to a rental agreement

WHEREAS Respondent Magliaro acknowledges that she has been made aware of her right to a full and formal hearing on any violations which the Commission may allege she has committed and his right to have the advice of counsel on the matters to which this Consent Order pertains, she is knowingly and voluntarily waiving the right to a hearing and counsel; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

Respondent Magliaro agrees to pay a fine in the amount of \$1500.00; and it is further ordered and agreed that

Respondent Magliaro shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:

And it appearing that this matter can be resolved upon the consent of the parties, without resort to any other further administrative proceeding;
