WHEREAS Respondent Jeffrey Spector a licensed New Jersey real estate salesperson, is subject to the provisions of the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq.; and

WHEREAS at all times relevant hereto, Jeffrey Spector was and continues to be licensed as a salesperson with Keller Williams Realty Team Monmouth, 750 Broad Street, Shrewsbury, NJ 07702; and

WHEREAS the Real Estate Commission has secured evidence which indicates that Respondent Spector has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and Respondent Spector have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS Respondent Spector acknowledges that he has been made aware of his right to a full and formal hearing on any violations which the Commission may allege he has committed and his right to have the advice of counsel on the matters to which this Consent Order pertains, he is knowingly and voluntarily waiving the right to a hearing and counsel; and

WHEREAS, Respondent Spector admits that he acted in violation of N.J.S.A. 45:15-17(g) and N.J.A.C. 11:5-6.1(m) by using an advertising method which involved a lottery.

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

Respondent Spector agrees to pay a fine in the amount of 750.00; and it is further ordered and agreed that

Respondent Spector shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:


