

In The Matter of:

Ofir Hillel (Ref. No. 0235299), Licensed Real Estate Broker/Respondent

WHEREAS RESPONDENT Ofir Hillel, a licensed Real Estate Broker licensed by the State of New Jersey, is subject to the provisions of the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq.; and

WHEREAS at all times relevant hereto, Ofir Hillel was and continues to be the broker of record of Orange Key Realty, 863 Georges Road, Monmouth Junction, NJ 08852; and

WHEREAS the Real Estate Commission has secured evidence which indicates that RESPONDENT Hillel has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and Respondent Hillel have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS Respondent Hillel acknowledges that he has been made aware of his right to a full and formal hearing on any violations which the Commission may allege he has committed and his right to have the advice of counsel on the matters to which this Consent Order pertains, he is knowingly and voluntarily waiving the right to a hearing and counsel; and

WHEREAS Respondent Hillel admits that he acted in violation of N.J.A.C. 11:5-4.2(a) by failing to supervise the activities of salespersons under his employ, specifically the failure of his salespersons to timely collect all deposits moneys required under the contracts prepared by his office; and

WHEREAS Respondent Hillel admits that he acted in violation of N.J.A.C. 11:5-6.4(a) by failing to collect the second deposit in the 18 Lakeview Drive, Helmetta, NJ transaction

(contract indicated a second deposit was to be paid after attorney review, the funds were not collected and instead forwarded directly to the attorney); and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

RESPONDENT Hillel agrees to pay a fine in the amount of \$3000.00; and it is further ordered and agreed that

RESPONDENT Hillel shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:



It is further ORDERED AND AGREED that the Commission reserves the right to take further administrative action if the terms of this Consent Order are not fully complied with or if it obtains any other information that the respondent may have violated the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq. or corresponding regulations, N.J.A.C.11:5-1.1 et seq.;
