WHEREAS Respondent Gregory Laubert, a licensed real estate salesperson licensed by the State of New Jersey, is subject to the provisions of the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq.; and

WHEREAS at all times relevant hereto, Respondent Gregory Laubert was and continues to be licensed with Shore Options, Inc. d/b/a Re/Max Atlantic whose office is located at 703 White Horse Pike, Absecon, NJ; and

WHEREAS the Real Estate Commission has secured evidence which indicates that Respondent Laubert has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and Respondent Laubert have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS Laubert acted as a disclosed dual agent for the lease transaction for the property located at 5712 Gloria Lane, Egg Harbor City, NJ November 15, 2012; and

WHEREAS on November 9, 2012 the tenant gave a check for the security deposit, in the amount of \$1,500 payable to "Re/Max Atlantic" to Laubert; and

WHEREAS the check was placed into the file and ultimately turned over by Laubert and deposited by Re/MAX Atlantic on November 20, 2014; and

WHEREAS, Respondent Laubert admits that he acted in violation of N.J.S.A. 45:15-17(d) by failing to account for or to pay over moneys belonging to others coming into his possession; and

WHEREAS Respondent Laubert acknowledges that he has been made aware of his right to a full and formal hearing on any violations which the Commission may allege he has committed and his right to have the advice of counsel on the matters to which this Consent Order pertains, he is knowingly and voluntarily waiving the right to a hearing and counsel; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

Respondent Laubert agrees to pay a fine in the amount of \$1500.00; and it is further ordered and agreed that

Respondent Laubert shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:



It is further ORDERED AND AGREED that the Commission reserves the right to take further administrative action if the terms of this Consent Order are not fully complied with or if it obtains any other information that the respondent may have violated the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq. or corresponding regulations, N.J.A.C. 11:5-1.1 et seq.;


