WHEREAS Respondent Michael Pullia, a licensed Real Estate broker licensed by the State of New Jersey, is subject to the provisions of the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq.; and

WHEREAS Pullia is licensed as broker of record of ML Ruberton Agency, whose main office is located at 401 12th Street, Hammonton, New Jersey; and

WHEREAS the Real Estate Commission has secured evidence which indicates that Respondent Pullia has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and Respondent Pullia have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS Respondent Pullia acknowledges that he has been made aware of his right to a full and formal hearing on any violations which the Commission may allege he has committed and his right to have the advice of counsel on the matters to which this Consent Order pertains, he is knowingly and voluntarily waiving the right to a hearing and counsel; and

WHEREAS Respondent Pullia admits that he acted in violation of N.J.A.C. 11:5-5.1(e) by failing to promptly deposit funds received in the 156 Broadway, Hammonton, NJ transaction.

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

RESPONDENT Pullia agrees to pay a fine in the amount of \$1500.00; and it is further ordered and agreed that

RESPONDENT Pullia shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:


