WHEREAS Respondent Jennifer J. Colamedici, a licensed real estate broker licensed by the State of New Jersey, is subject to the provisions of the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq.; and

WHEREAS at all times relevant hereto, Respondent Jennifer J. Colamedici was and continues to be licensed as the Broker of Record with RES Realty LLC d/b/a Re/Max Select, whose office is located at 137-139 Elmer Street, Westfield, NJ 07090; and

WHEREAS the Real Estate Commission has secured evidence which indicates that Respondent Colamedici has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and Respondent Colamedici have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS, Respondent Colamedici admits that she acted in violation of N.J.A.C. 11:5-4.5(e), by failing to record the name of the branch office supervisor of the Rockaway branch of Re/Max Select with the Commission; and

WHEREAS Respondent Colamedici acknowledges that she has been made aware of her right to a full and formal hearing on any violations which the Commission may allege she has committed and her right to have the advice of counsel on the matters to which this Consent Order pertains, she is knowingly and voluntarily waiving the right to a hearing and counsel; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

Respondent Colamedici agrees to pay a fine in the amount of \$1,000.00; and

Respondent Colamedici shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:

And it appearing that this matter can be resolved upon the consent of the parties, without resort to any other further administrative proceeding;

ORDERED and AGREED that the terms of this Consent Order are approved by the Commission at a regular meeting on APRIL 30, 2019; and

It is further ORDERED AND AGREED that the Commission reserves the right to take further administrative action if the terms of this Consent Order are not fully complied with or if it obtains any other information that the respondent may have violated the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq. or corresponding regulations, N.J.A.C. 11:5-1.1 et seq.;
